TO THE HONORABLE BOARD OF COUNTY COMMISSIONERS,
ANOKA COUNTY, MINNESOTA:

The undersigned, T. C. Blomgren, as the Administrator of the Estate of Fred Johnson, Decedent, respectfully represents and shows to your Board as follows, to-wit:


That prior to his death the said Fred Johnson, now deceased, was awarded the contract for the construction of County Ditch Number 58 in said County of Anoka, and that he duly gave a surety bond providing for the faithful performance of said Contract in the sum of \$21,700.00.

That the said contract has been so far completed that there is no necessity at this time for the said bond to be continued in the said sum and amount of \$21,700.00, all of which duly appears by the reports and certificates of the Engineer in charge of the construction of said Ditch as now on file and of record in the office of the County Auditor of the said County ~~auditor~~ of Anoka, Minnesota, and as I believe to the satisfaction of your Board, and that no loss will or can result by the reduction in the amount of said bond, and that your petitioner as the Administrator of the Estate of said Fred Johnson, Decedent, is entitled to an order substantially reducing the amount of said bond.

That in the opinion of your petitioner based upon the amount of work completed under said contract and the amount of work yet to be completed that the said Bond can safely be reduced to the sum and in the amount of not to exceed the sum of ten thousand dollars.

WHEREFORE, Your petitioner as such Administrator prays that the amount of said bond be reduced to such amount and sum as to your Board may appear just and in accordance with the safety of all persons interested therein.
