WHEREAS, A petition has been filed, bearing date the 30th day of June, 1915, praying for the establishment of a public ditch in said county along the route described in said petition, together with a proper bond accompanying the same, and the said petition has been heard and considered by the Board of County Commissioners of said county at their meeting held on the 19th day of January, 1916, pursuant to notice of said hearing duly published and posted as by law required, and the said Board of County Commissioners has appointed a competent civil engineer, to-wit: Wayne L. Ridge, to make a complete survey of said ditch and of the route thereof, who has on the 22nd day of November, 1916, filed his report of said survey in my office, and the said Board of County Commissioners have appointed Ole Lagerson and H. Edmunds and Ivan Anderson to be viewers of said proposed ditch by their order filed herein in my office on the 19th day of January, 1916,

Now, Therefore, It Is Hereby Ordered, That the said viewers be and meet at the court house in the City of Anoka in said county, on the 23rd day of November, 1916, at 11 o'clock in the forenoon of said day, preparatory to assuming and commencing their duties as such viewers, said time being within fifteen days after the filing of the engineer's report of his survey in said matter.
