The place of commencement of said Ditch at its source is as follows:
at a point at or near the North East corner of the South
west quarter of the South East Quarter of Section 10 Township
32 Range 24 thence running in a general westerly and south-
westerly direction for one mile more or less through sections 15
to section 16 thence in a general westerly and northwesterly di-
rection through sections 16, 17, 8 & 7 following as near as prac-
ticable the natural water courses through said Sections.
