The Condition of the Above Obligation is Such, That whereas the above bounden JAMES T. ELWELL and C. P. LOVELL

have filed a petition with the County Auditor of ANDOKA County, State

of Minnesota, praying for the establishment and construction of a public Ditch, Drain or Water Course

along the following described route: Commencing at or near a point eighty [80] rods south of the West quarter post of Section Twenty Six [26] Town Thirty one [31] Range Twenty Three [23] Thence running in a southerly and westerly direction over and across Section Twenty Seven [27] and Thirty Four [34] in said township and range terminating at a point on the county line at or near the south quarter post of said Section Thirty Four [34] Township Thirty One [31] Range Twenty Three [23], as its outlet.

Now, if the said JAMES T. ELWELL and C. P. LOVELL

shall pay all expenses, in case the Board of County Commissioners of said County shall fail to establish said proposed Ditch, Drain or Water Course then the above obligation to be void, otherwise to remain in full force and virtue.
