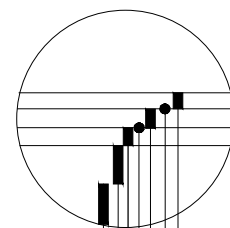
MEDIAN W/ BITUMINOUS REPLACEMENT

RADISSON ROAD (NORTH)



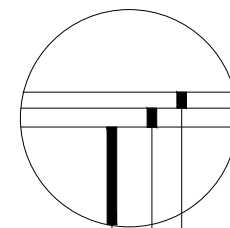

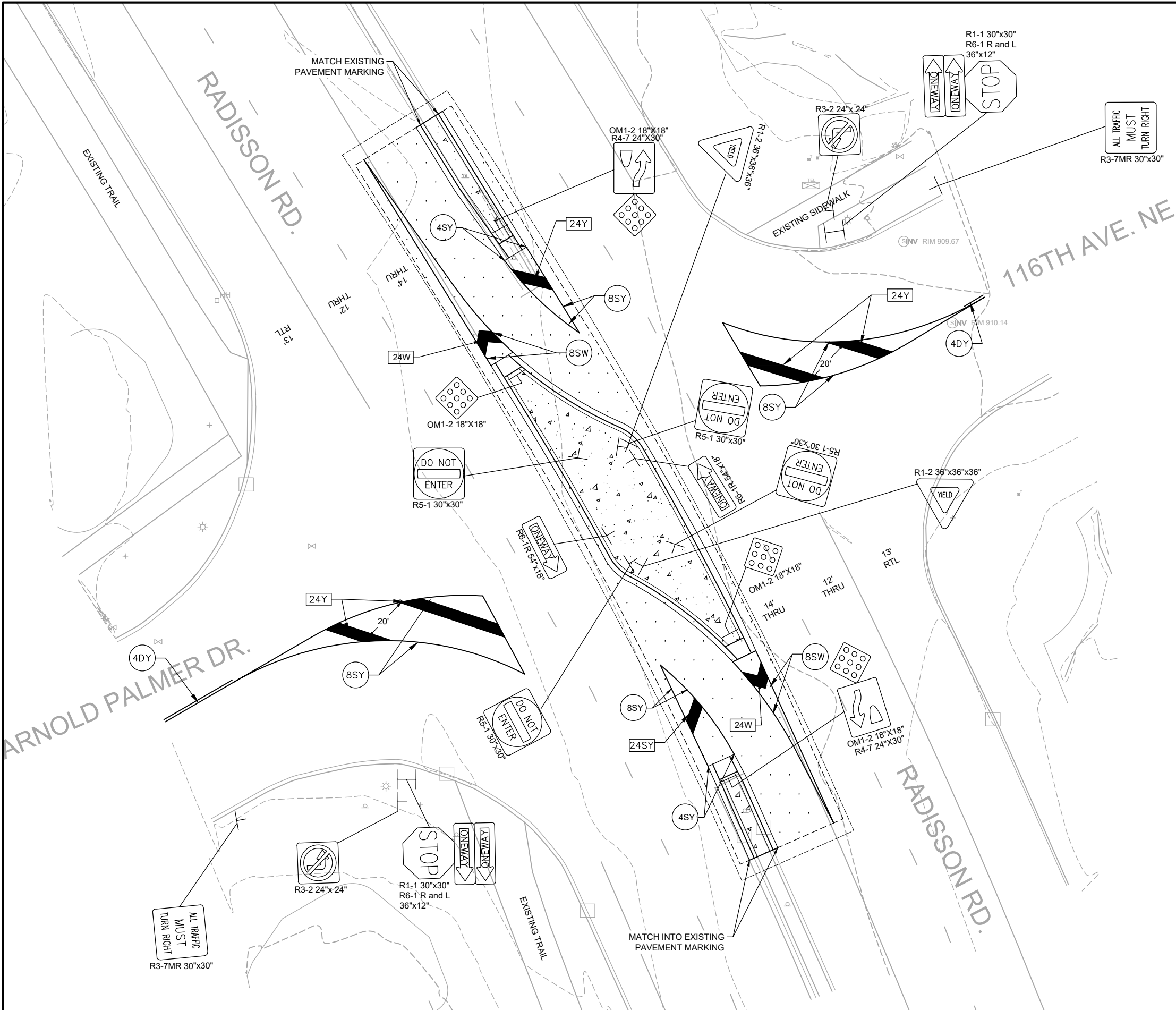
