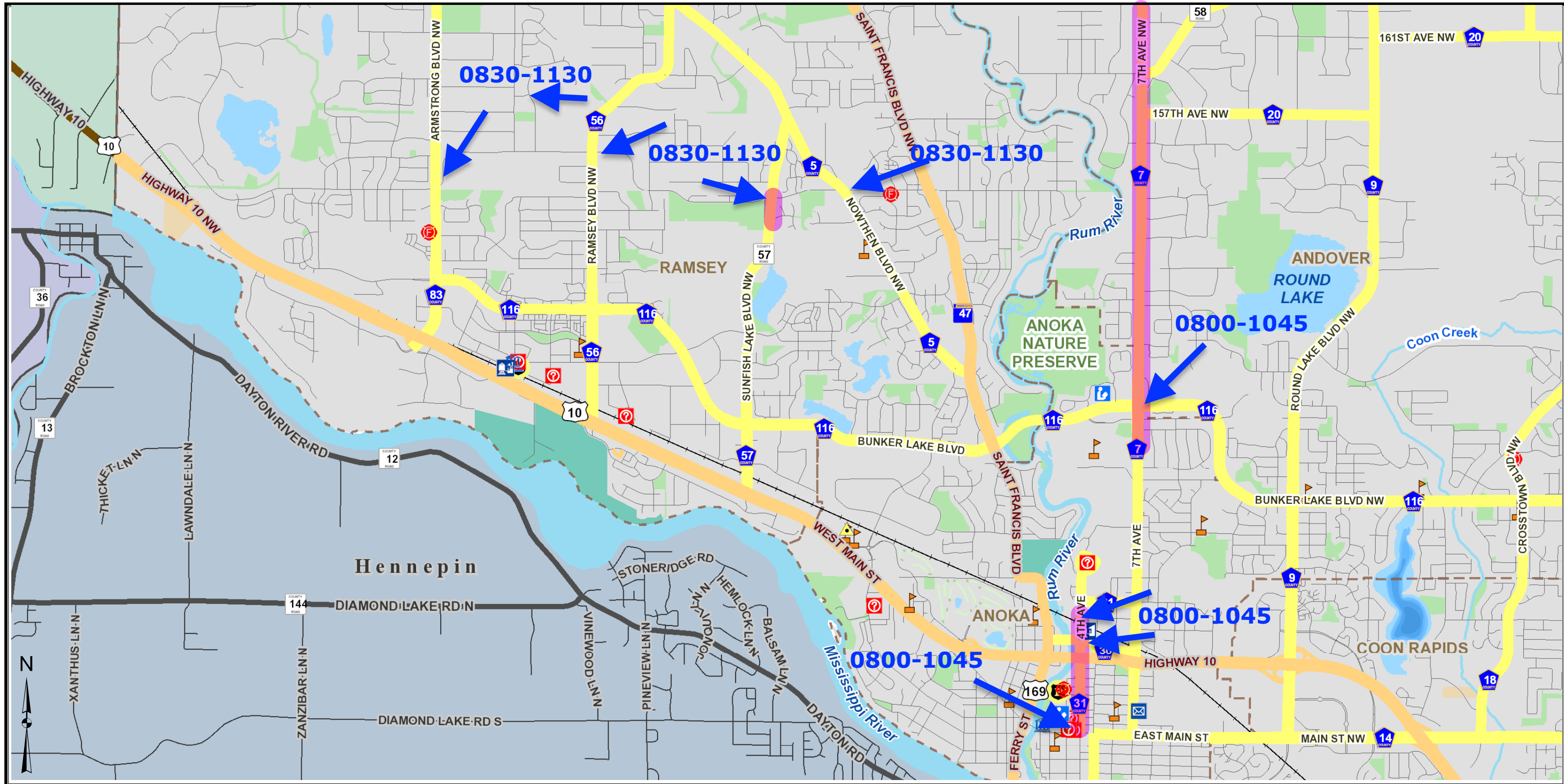
Please note the following for potential hazards:

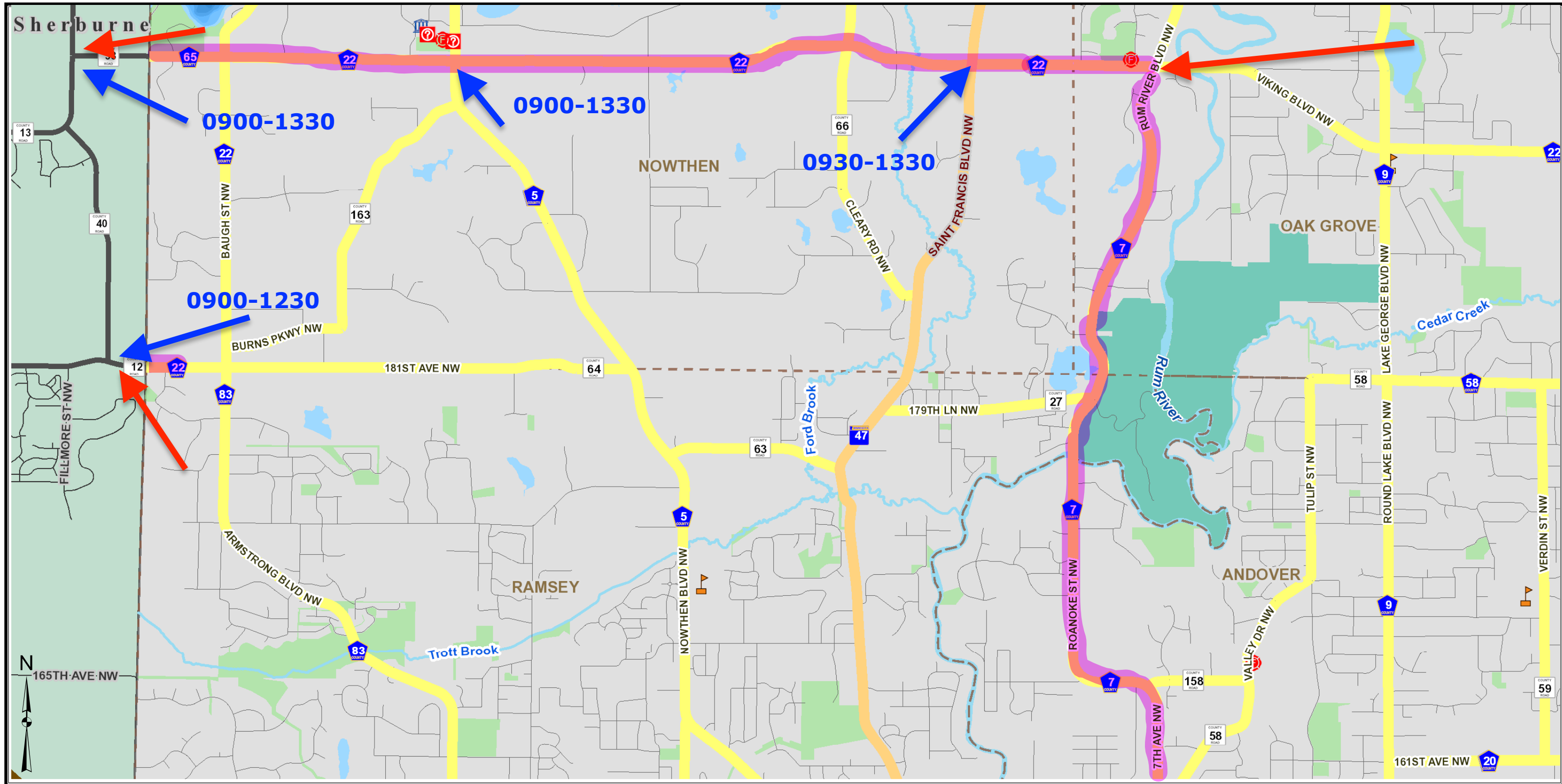
