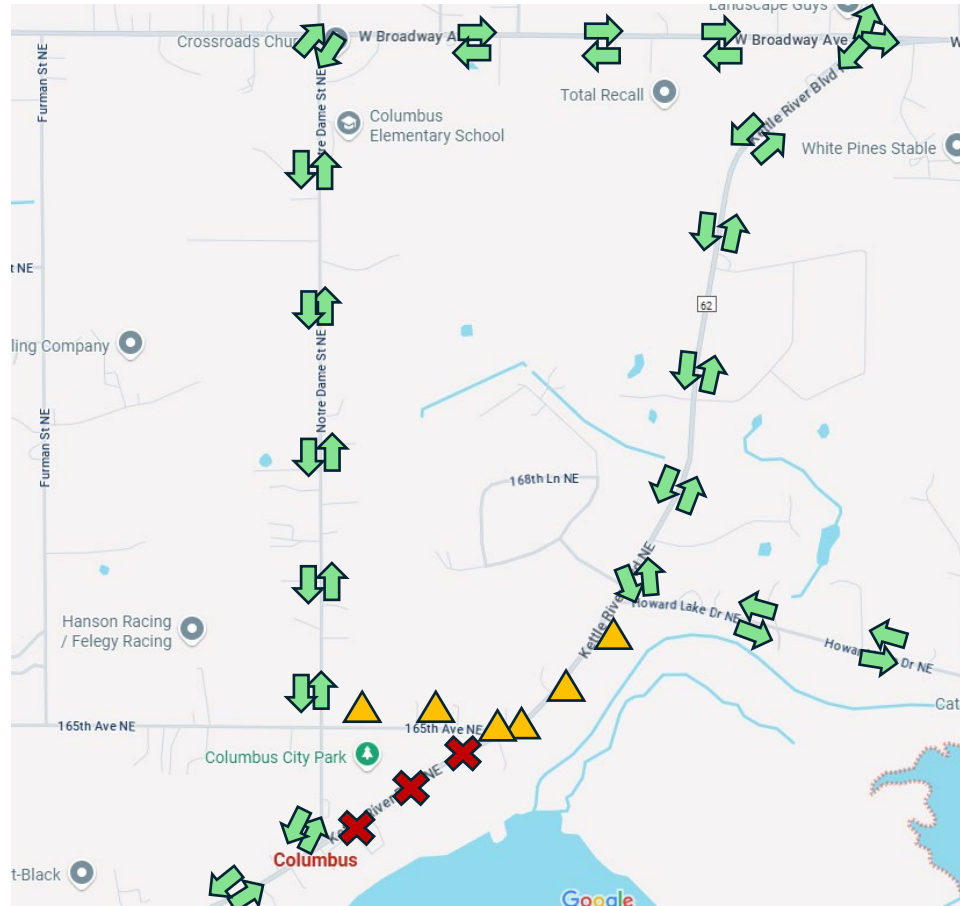

Columbus Fall Fest Road Closure / Detour Request

Location: Columbus, MN City Hall / Park

Time: 10am-7pm

County Road Detour (Green): All are paved roadways and sufficient for higher volume traffic. The detour creates minimal impact and would only add 2-3 minutes onto a drive.

- County Road 62 (Kettle River Blvd.) → Notre Dame St. → County Road 18 (Broadway Ave.)
- County Road 18 (Broadway Ave.) → Notre Dame St. → County Road 62 (Kettle River Blvd.)

Local Traffic Only Areas (Yellow): We are trying to keep this area to local residents only who are wanting to attend and park at the event. 165th is a dirt road and not sufficient for detouring county road traffic.

- 165th Ave NE. east of Notre Dame
- Kettle River Blvd. North between city hall and Howard Lake Dr.

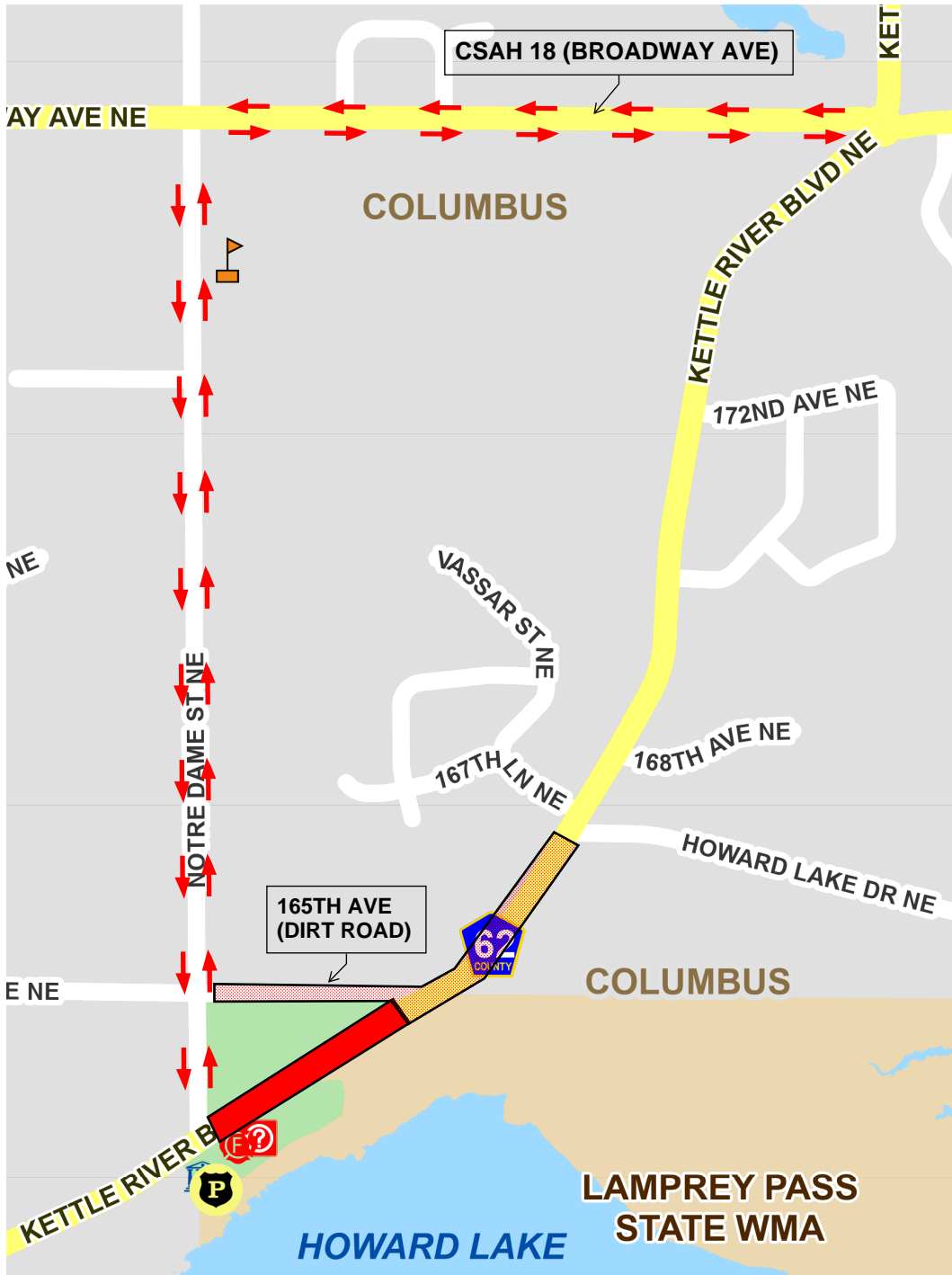
