
ANDERSON FIRST ADDITION

Know all man by these presents that we, Paul L. Anderson and Frieda I. Anderson, his wife, as joint tenants, owners and proprietors of the following described property situate in the State of Minnesota and County of Anoka towit: That part of Section 36, Township 30, Range 24 described as follows: Commencing at a point on the Westerly line of Reservior Boulevard, as the same is now laid out and opened in the City of Columbia Heights, Minnesota, which point is 698 feet South of the North line of said Section 36; thence West on a line parallel with the North line of said Section 36 to a point thereon distant 360 feet East of, measured at right angles to a Easterly boundary line of the plat of "Reservior Hills", according to the plat thereof on file and of record in the Register of Deeds in and for Anoka County, Minnesota, said described point being the actual point of beginning of the tract of land to be described; thence continuing Westerly on a line parallel with the North line of said Section 36 to the Easterly boundary line of the plat of said "Reservior Hills" to the angle point in said Easterly boundary line; thence Easterly along a Northerly boundary line of said "Reservior Hills" to its intersection with a line drawn from the actual point of beginning and parallel with the Easterly boundary line of said "Reservior Hills" as described heretofore in this description; thence Northerly along said, line, so drawn, to the actual point of beginning, according to the United States Government Survey thereof, have caused the same to be surveyed and platted as ANDERSON FIRST ADDITION; and do hereby donate and dedicate to the public for the public use forever, M°Leod Street Northeast and Royce Street Northeast as shown on the annexed plat, however, to the easement for utility purposes as shown on the annexed plat.
