


Outlot D, ANOKA ENTERPRISE PARK FIFTH ADDITION, Anoka County, Minnesota.

That part of the Southwest Quarter of the Northwest Quarter of Section 36, Township 32, Range 25, Anoka County, Minnesota, lying southeasterly of the centerline of Thurston Avenue, EXCEPT that part lying southwesterly and southeasterly of the following described line: Commencing at the southwest corner of said Southwest Quarter of the Northwest Quarter; thence northerly along described line: Commencing at the southwest corner of said Southwest Quarter of the Northwest Quarter; thence northerly along the west line thereof 448.05 feet to the intersection with the centerline of said Thurston Avenue; thence North 59 degrees 42 minutes 38 seconds East along said centerline 694.16 feet; thence northeasterly along said centerline 247.38 feet on a tangential curve concave to the northwest having a radius of 697.75 feet, a central angle of 20 degrees 18 minutes 48 seconds; thence North 39 degrees 23 minutes 50 seconds East, tangent to said curve, 73.97 feet along said centerline to the point of beginning of said line; thence South 43 degrees 57 minutes 34 seconds East 357.01 feet; thence South 36 degrees 10 minutes 23 seconds East 263.08 feet; thence North 67 degrees 04 minutes 52 seconds East 63.85 feet; thence northeasterly 33.57 feet along a tangential curve concave to the southeast having a radius of 330.00 feet, a central angle of 5 degrees 49 minutes 41 seconds to the east line of said Southwest Quarter of the Northwest Quarter and said line there terminating. EXCEPT that part platted as JACKSON ADDITION, subject to easements of record.

Has caused the same to be surveyed, platted and known as ANOKA ENTERPRISE PARK SEVENTH ADDITION and do hereby donate and dedicate to the public for public use forever the avenue and drainage and utility easements as shown on this plat. 


