
## BENDEMERE ADDITION

KNOW ALL MEN BY THESE PRESENTS: that we, Eldon W. Mason and Alice J. Mason, his wife, owners and proprietors, and Donald K. Elvig and Merrywayne R. Elvig, his wife, and Dayton D. Burkholder and Barbara E. Burkholder, his wife, contract purchasers, and the Northwestern National Bank of Minneapolis, Minneapolis, Minnesota, mortgagee of the following described property situate in the County of Anoka and State of Minnesota to-wit: that part of Outlot 3 in N. D. Shaw's Addition to Anoka described as follows: commencing at the most Southerly point of said Outlot 3, thence Northeasterly along the Southeasterly line of said Outlot 3 a distance of 487 feet to the most Easterly point of said Outlot 3, thence Northwesterly along the Northeasterly line of said Outlot 3 a distance of 242 feet to a point, thence Southwesterly in a direct line to a point on the Mississippi River 200 feet Northwesterly from the point of commencement, thence Southeasterly along said Mississippi River a distance of 200 feet to the place of commencement, according to the duly recorded plat thereof on file and of record in the office of the Register of Deeds in and for Anoka County, Minnesota; and hereby donate and dedicate to the public use forever the Lane as shown on the annexed plat; also subject to utility and drainage easements as shown on the annexed plat.
