WHICH CORNER IS ALSO THE SOUTHEAST CORNER OF SECTION 35, TOWNSHIP 32, RANGE 25; THENCE WEST ALONG THE SOUTH LINE OF SAID LOT AND SECTION 407.22 FEET; THENCE NORTH ON THE WEST LINE OF SAID LOT FIVE (5) A DISTANCE OF 75.54 FEET; THENCE EAST 407.22 FEET TO A POINT ON THE EAST LINE OF SAID LOT AND SECTION WHICH IS 77.54 FEET NORTH OF THE POINT OF BEGINNING OF THIS DESCRIPTION; THENCE SOUTH 77.54 FEET TO THE POINT OF BEGINNING, EXCEPT THAT PART OF THE ABOVE LANDS DESCRIBED AS FOLLOWS: COMMENCING AT THE SOUTHEAST CORNER OF SAID SECTION THIRTY-FIVE (35); THENCE NORTH ALONG THE EAST LINE THIRTY-FIVE (35); THENCE WEST PARALLEL WITH THE NORTH LINE OF SAID SOUTH ONE HALF OF THE SOUTH-EAST QUARTER (S2 S2 SE4) OF SAID SECTION THIRTY-FIVE (35) A DISTANCE OF FIFTY (50) FEET; THENCE SOUTH AND PARALLEL WITH THE EAST LINE OF SAID SECTION THIRTY-FIVE (35) A DISTANCE OF 77.93 FEET; THENCE SOUTHEASTERLY AND TO THE LEFT ON A TANGENTIAL CURVE HAVING A RADIUS OF FIFTY (50) FEET A DISTANCE OF 78.31 FEET, MORE OR LESS, TO ITS INTERSECTION WITH THE EAST LINE OF SAID SECTION THIRTY-FIVE (35) EXTENDED SOUTH; THENCE NORTH ALONG SAID LINE A DISTANCE OF THIRTY (30) FEET TO THE POINT OF COMMENCEMENT. ALL THAT PART OF HIGHLAND AVENUE, VACATED, LYING NORTHERLY OF THE EASTERLY EXTENSION OF THE SOUTH LINE OF LOT FIVE (5), BLOCK SIX (6); EXCEPT THE NORTHERLY THIRTY (30) FEET OF LOT EIGHTEEN (18), BLOCK FOUR (4); AND THE NORTHERLY THIRTY (30) FEET OF HIGHLAND PARK ADDITION TO THE AND THE NORTHERLY THIRTY (30) FEET OF LOT EIGHTEEN (18), BLOCK FOUR (4); AND THE NORTHERLY THIRTY (30) FEET OF LOT EIGHTEEN (18), BLOCK FOUR (4). ALL IN HIGHLAND PARK ADDITION TO THE CITY OF ANOKA. ALSO THE CHURCH OF STEPHEN OF ANOKA, MINNESOTA HAS CAUSED THESE PRESENTS TO BE SIGNED BY ITS PROPER OFFICERS AND ITS CORPORATE SEAL TO BE HEREUNTO AFFIXED ON THIS 21 ST DAY OF APRIL A.D. 1966.
