KNOW ALL MEN BY THESE PRESENTS: That we Arvid E. Carlson & Son, Inc., a Minnesota corporation, owners and proprietors, and C.A. Nelson Farms, Inc., a Minnesota corporation, and A.E. Riedel Company, a Minnesota corporation, mortgagees of the following described property situate in the County of Anoka, State of Minnesota, to wit:
