KNOW ALL PERSONS BY THESE PRESENTS: That Lee A. Hennen, owner and proprietor, and Verna F. Hennen, husband and wife, of the following described property situated in the County of Anoka, State of Minnesota, to-wit:

Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 16 and 17, and Outlot A, OAK GROVE RIVER LOTS, according to the recorded plat thereof, Anoka County, Minnesota, together with that part of vacated River Boulevard, as dedicated in said plat, accruing to said lots by reason of the vacation thereof, the east line of said Lot 17 being described as follows:

Commencing at a point on the east line of the Northwest Quarter of the Northeast Quarter of Section 5, Township 33, Range 24, Anoka County, Minnesota, distant 1229.88 feet southerly of the northeast corner thereof, for the purposes of this description, the east line of the Southwest Quarter of the Southeast Quarter of Section 32, Township 34, Range 24, is assumed to bear North 00 degrees 15 minutes 14 seconds West; thence North 85 degrees 06 minutes 17 seconds West, a distance of 627.40 feet; thence South 00 degrees 17 minutes 32 seconds East, a distance of 33.14 feet to the northeast corner of said Lot 17 and the point of beginning of the line being described; thence South 00 degrees 17 minutes 32 seconds East, a distance of 6 feet, more or less, to the northerly shore line of the Rum River, and there terminating.

AND

That part of the Northwest Quarter of the Northeast Quarter of Section 5, Township 33, Range 24, Anoka County, Minnesota, and that part of the Southwest Quarter of the Southeast Quarter of Section 32, Township 34, Range 24, Anoka County, Minnesota, described as follows:

Commencing at the southeast corner of said Southwest Quarter of the Southeast Quarter; thence on an assumed bearing of North 00 degrees 15 minutes 14 seconds West, along the east line of said Southwest Quarter of the Southeast Quarter, a distance of 294.99 feet to the intersection with the easterly extension of the north line of WALTERS ADDITION, according to the recorded plat thereof, Anoka County, Minnesota; thence South 89 degrees 52 minutes 12 seconds West along said easterly extension and along the north line of said WALTERS ADDITION, a distance of 572.00 feet to the northwest corner of said WALTERS ADDITION, and the point of beginning of the land to be described; thence continuing South 89 degrees 52 minutes 12 seconds West, a distance of 396.00 feet; thence South 00 degrees 07 minutes 48 seconds East, a distance of 280.80 feet to the south line of said Southwest Quarter of the Southeast Quarter and the north line of said OAK GROVE RIVER LOTS; thence South 89 degrees 17 minutes 28 seconds East along the south line of said Southwest Quarter of the Southeast Quarter and along the north line of said OAK GROVE RIVER LOTS, a distance of 332.05 feet to the most northerly northeast corner of said OAK GROVE RIVER LOTS; thence South 00 degrees 20 minutes 00 seconds East, along the east line of said OAK GROVE RIVER LOTS, a distance of 291.84 feet to an angle point in said east line; thence North 89 degrees 52 minutes 12 seconds East, along the north line of said OAK GROVE RIVER LOTS, a distance of 65.00 feet to the southwest corner of said WALTERS ADDITION; thence North 00 degrees 20 minutes 02 seconds West, along the west line of said WALTERS ADDITION, a distance of 577.50 feet to the point of beginning.

(Said tract is also known as part of Lot 1, Block 8, "Village of St. Francis").

Lots 1, 2, 3, and 4, Block 1 and Lots 3, 4, 5, 6, and 7, Block 2, WALTERS ADDITION, according to the recorded plat thereof, Anoka County, Minnesota. AND

That part of vacated Quay Street, as dedicated in the plat of WALTERS ADDITION, according to the recorded plat thereof, Anoka County, Minnesota, lying south of the westerly extension of the south line of Lot 2, Block 2, said WALTERS ADDITION.

Have caused the same to be surveyed and platted as DELLWOOD RIVER ESTATES and do hereby donate and dedicate to the public for public use forever the avenues, court, streets and drainage and utility easements as shown on the plat.
