

KNOW ALL MEN BY THESE PRESENTS: That we Harry Duffy and Jane Gillis Duffy his wife, owners and proprietors of the following described property to-wit; That part of Lot 10 Auditor's Subdivision Number 11 according to the plat thereof on file and of record in the office of the Register of Deeds, Anoka County, Minnesota described as follows; Beginning at a point on the north line of said Lot 10 four hundred sixty-five and eight tenths (465.8) feet west of the northeast corner thereof, hence south parallel to the east line of said Lot 10 five hundred ten (510) feet to the south line of said Lot 10, thence west along the south line of said Lot 10 three hundred twenty-eight and five tenths (328.5) feet to the southwest corner of said Lot 10, thence north along the west line of said Lot 10 three hundred sixty (360) feet; thence east parallel to the north line of said Lot 10 one hundred sixty-five (165) feet, thence north parallel to the west line of said Lot 10 seventy-five (75) feet, thence west parallel to the north line of said Lot 10 one hundred sixty-five (165) feet, thence north seventy-five (75) feet to the northwest corner of said Lot 10, thence east three hundred twenty-seven and five tenths (327.5) feet to the point of beginning, have caused the same to be surveyed and platted as "DUFFY'S RIVERVIEW SUBDIVISION NUMBER TWO" Anoka, Minnesota and do hereby donate and dedicate to the public use forever the streets and avenues as shown on the annexed Plat.
