That part of the Southeast Quarter of the Southwest Quarter of Section 24, Township 31, Range 23, Anoka County, Minnesota, described as follows: Beginning at a point on the South line of said Southeast Quarter of the Southwest Quarter a distance of 346.00 feet West from the Southeast corner thereof; thence North parallel with the East line of said Southeast Quarter of the Southwest Quarter, a distance of 430.50 feet; thence West parallel with the South line of said Southeast Quarter of the Southwest Quarter, a distance of 363.00 feet; thence South parallel with said East line a distance of 430.50 feet to said South line; thence East along said South line a distance of 363.00 feet to the point of beginning.

Excepting therefrom the following described tract:

That part of the Southeast Quarter of the Southwest Quarter of Section 24, Township 31, Range 23, Anoka County, Minnesota, described as follows: Beginning at a point on the South line of said Southeast Quarter of the Southwest Quarter a distance of 346.00 feet West from the Southeast corner thereof; thence continue along said South line of the Southeast Quarter of the Southwest Quarter, on an assumed bearing of North 89 degrees 49 minutes 10 seconds West, a distance of 119.00 feet; thence North 00 degrees 10 minutes 50 seconds East, a distance of 50.00 feet; thence on a tangential curve concave westerly, said curve's radius being 527.00 feet and having a central angle of 09 degrees 21 minutes 00 seconds, a distance of 86.00 feet; thence North 89 degrees 49 minutes 10 seconds East, a distance of 125.10 feet to a point on a line from the point of beginning, said line being parallel with the East line of said Southeast Quarter of the Southwest Quarter; thence South 00 degrees 45 minutes 40 seconds East along said parallel line 155.96 feet to the actual point of beginning.

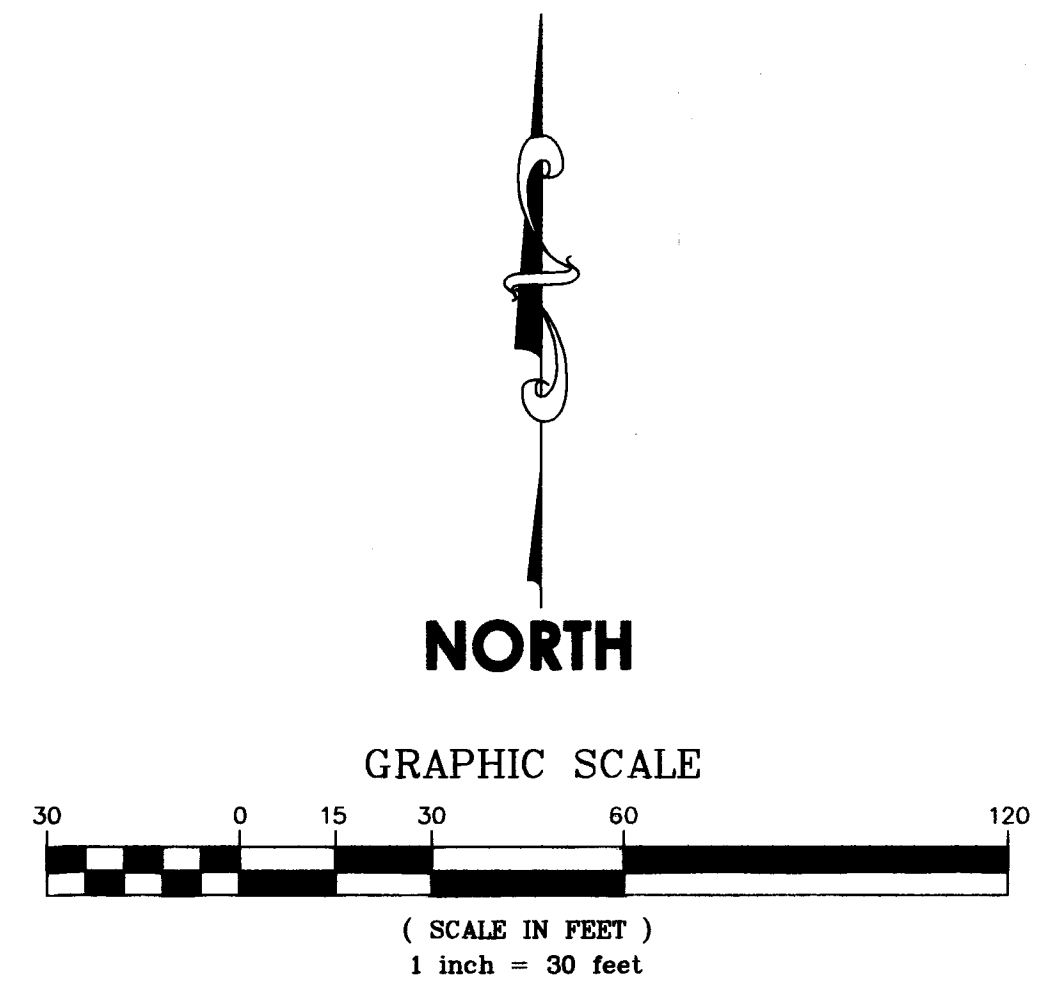
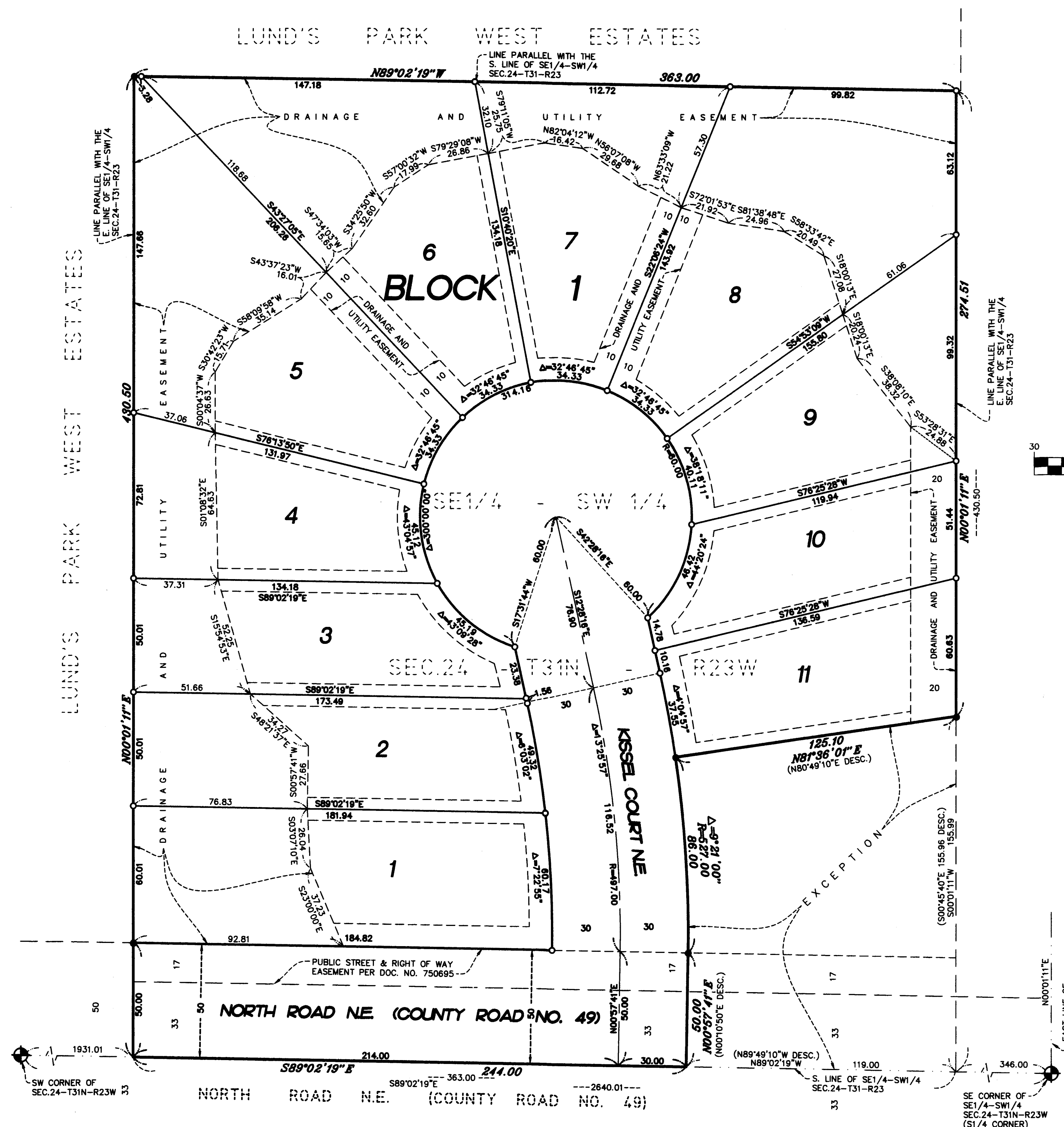

### BOUNDARY NOTE

Section 24, Township 31, Range 23, has historically used a monumented center of section position for previous surveying work. The plat of LUND'S PARK WEST ESTATES, which adjoins this parcel, used the monumented center position for the platted boundary. This plat uses the monumented center position for establishing the boundary of this parcel.
