KNOW ALL PERSONS BY THESE PRESENTS: That Oliver R. Erickson, owner and proprietor and Edna D. Erickson, husband and wife, and Crosstown State Bank of Ham Lake, Inc., a Minnesota corporation, mortgagee of the following described property situated in the County of Anoka, State of Minnesota, to-wit:
