Commencing at the aforementioned Point A; thence South 8 degrees 51 minutes 30 seconds West a distance of 57.60 feet to a point in a line 33 feet South of (measured at right angles) and parallel with the North line of said Section 7; thence continuing on last described course a distance of 246.20 feet to the actual point of beginning of the tract herein described; thence continue Southwesterly on last described course a distance of 246.20 feet; thence Easterly parallel with the North line of said Section 7 a distance of 40 feet; thence Northerly to the actual point of beginning.


