
OFFICIAL PLAT

## HEATHER HILLS SECOND ADDITION CITY OF FRIDLEY COUNTY OF ANOKA



KNOW ALL MEN BY THESE PRESENTS: That M & M Properties, a partnership, owner and proprietor of the following described property situated in the State of Minnesota and County of Anoka, to wit: That part of Lot 23, in Auditor's Subdivision No. 22 lying north of the following described line; beginning at a point on the east line of said Lot 23 a distance of 245 feet south of the Northeast corner of said Lot 23; thence Northwesterly at an angle to the right of 91° 13' 26" a distance of 140.36 feet; thence at a deflection to the left of 48° 23' 32" a distance of 73.54 feet; thence at a deflection to the right of 48° 23' 32" a distance of 465.32 feet to its intersection with the West line of said Lot 23, and there terminating; said intersection point being 300.00 feet south of the Northwest corner of said Lot 23; except therefrom the following described parcel; beginning at a point in the North line of and 190.37 feet west of said Northeast corner of said Lot 23; thence southwesterly on a curve to the left with a radius of 325 feet and a delta angle of 21° 16' 38" a distance of 120.69 feet; the chord of said curve makes an angle with said North line of 11° 51' 45"; thence Northwesterly a distance of 25.11 feet to a point on said North line 122.14 feet west of the point of beginning; thence east to the point of beginning. All located within the Southwest Quarter (SW1/4) of the Southeast Quarter of Section 13, Township 30N, Range 24W.
