KNOW ALL MEN BY THESE PRESENTS: That Gary L. Zimmerman, a single person, fee owner, of the following described property situated in the county of Anoka, State of Minnesota, to wit:

That part of the Southeast Quarter of the Northwest Quarter of Section 27, Township 34, Range 24, which lies southerly and westerly of County Road No. 72 and which lies easterly of the plat of WYATT'S ADDITION. Except that part of said Southeast Quarter of the Northwest Quarter described as follows:

Commencing at the northwest corner of said Southeast Quarter of the Northwest Quarter of said Section 27; thence on an assumed bearing of South 89 degrees 43 minutes 24 seconds East, assumed bearing, along the north line of said Southeast Quarter of the Northwest Quarter a distance of 330.19 feet to the northeast corner of the plat of WYATT'S ADDITION and the point of beginning of the land to be described; thence continue South 89 degrees 43 minutes 24 seconds East 435.00 feet; thence southeasterly 21.00 feet along a tangential curve, concave to the south, having a central angle of 2 degrees 05 minutes 39 seconds and having a radius of 572.76 feet; thence South 3 degrees 16 minutes 35 seconds East 549.62 feet; thence North 89 degrees 43 minutes 24 seconds West 456.00 feet to the southeast corner of Lot 1, Block 3, WYATT'S ADDITION; thence North 3 degrees 16 minutes 35 seconds West along the east line of said WYATT'S ADDITION 550.00 feet to the point of beginning and there terminating.

Has caused the same to be surveyed and platted as HOBBY ACRES and does hereby donate and dedicate to the public for public use forever the road, avenue, and easements as shown on this plat for drainage and utility purposes only. Also dedicating to the County of Anoka the right of access onto County Road No. 72 as shown on the plat.


