
## IDLEWOOD 5TH ADDITION



KNOW ALL MEN BY THESE PRESENTS: That John M. Hansen and Marjorie S. Hansen, husband and wife, fee owners of the -following described property situate in the County of Anoka, State of Minnesota to wit:

That part of the West half of the Southeast Quarter of Section 26, Township 33, Range 23, described as follows: Beginning at a point on the West line of the West half of the Southeast Quarter, distant 967.91 feet North as measured along said West line of the Southwest corner of said West half of the Southeast Quarter, said point being the Northwesterly corner of Bayer and Hansen Addition, according to the plat thereof on file or of record in the office of the Register of Deeds, Anoka County, Minnesota; thence on an assumed bearing of North O degrees, 31 minutes, 26 seconds East along the West line of the West half of the Southeast Quarter, a distance of 658.24 feet; thence South 68 degrees, 50 minutes, 16 seconds East, a distance of 1426.80 feet to the East line of the West half of the Southeast Quarter, thence South O degrees, 53 minutes, 06 seconds West along said East line of the West half of the Southeast Quarter, a distance of 636.99 feet to the centerline of County State Aid Highway No. 22 according to the plat of Gary's Addition on file or of record in the office of the Register of Deeds, Anoka County, Minnesota; thence Northwesterly along the centerline of Viking Boulevard (C.S.A.H. 22), a distance of 36.96 feet, along a curve concave to the Northeast having a radius of 1145.92 feet, a central angle of 1 degree, 50 minutes, 52 seconds, the chord of said curve bears North 77 degrees, 16 minutes, 21 seconds West, to a curve spiral point; thence Northwesterly along said centerline on a 7 degree, 30 minutes, 300 foot spiral curve, a distance of 300 feet; thence North 68 degrees, 50 minutes, 16 seconds West tangent to the last described spiral curve along the centerline of Viking Boulevard (C.S.A.H. 22), a distance of 1079.51 feet to the point of beginning.

Have caused the same to be surveyed and platted as IDLEWOOD 5TH ADDITION and do hereby donate and dedicate to the public for public use forever the boulevard, street, avenue, road, and drainage and utility easements as shown on this plat; also dedicating to the County of Anoka the right of access to County State Aid Highway No. 22 (Viking Boulevard) from Lots 1 thru 10, Block 2 and Lot 15. Block 1 as shown on the plat.
