

KNOW ALL MEN BY THESE PRESENTS: That Julian M. Johnson Construction Corp., a Minnesota corporation, owner and proprietor of the following described property situated in the County of Anoka, State of Minnesota to wit: That part of the Southeast Quarter of the Northwest Quarter of Section 31, Township 31, Range 23, lying southeasterly of the plat of Dailey & Herda 6th Addition, excepting therefrom the South 633.00 feet and the East 195.00 feet. Also, that part of said Southeast Quarter of the Northwest Quarter described as follows: Beginning at a point on a line which is on the north line of the South 633.00 feet of said Northwest Quarter, said point being 330.00 feet West of the east line of said Northwest Quarter; thence West, along said north line, to its intersection with the easterly boundary line of Dailey & Herda 6th Addition; thence southwesterly, along said easterly boundary line, to the south line of the said Northwest Quarter; thence East, along said south line, to the west line of the East 1020.00 feet of said Northwest Quarter; thence North, along the last described west line, to its intersection with a line which is 100.00 feet southeasterly and parallel with said easterly boundary line of Dailey & Herda 6th Addition (said 100.00 feet measured at right angles to said easterly boundary line); thence northeasterly, along the last described parallel line, to its intersection with the north line of the South 168.00 feet of said Northwest Quarter; thence East, along last described north line, to its intersection with the west line of the East 531.00 feet of said Northwest Quarter; thence North, along last described west line a distance of 135.00 feet; thence northeasterly to a point in the west line of the East 432.00 feet of said Northwest Quarter, said last mentioned point being 363.00 feet North of the south line of said Northwest Quarter; thence North, along the last described west line, for a distance of 135.00 feet; thence East and parallel with the south line of said Northwest Quarter. for a distance of 102.00 feet; thence North 135.00 feet to the point of beginning;
