


KNOW ALL PERSONS BY THESE PRESENTS: That D-J Properties of Andover, LLC, a Minnesota Limited Liability Company, owner and proprietor, and Century Bank National Association, mortgagee of the following described property situated in the County of Anoka, State of

Government Lot Five (5) and Government Lot Six (6), Section Twenty Five (25), Township Thirty-three North (33N), Range Twenty-three West (23W), Anoka County, Minnesota, except the following described tracts:

- 1. That part of Government Lot 5 lying Northwesterly of the centerline of County State Aid Highway 22; and
- 2. That part of Government Lot 6 described as follows: Commencing at the Southwest corner of said Government Lot 6, thence North on the West line thereof 47 rods to the center of a private ditch, thence Southeasterly along the centerline of said private ditch 71 rods to a point on the South line of said Government Lot 6 which lies 55 rods East of the point of commencement; thence West alona said South line of said Lot 6 to the point of commencement; and
- 3. Those parts of said Government Lots 5 and 6 lying respectively in the Southwest Quarter of the Northeast Quarter and in the Northwest Quarter of the Southeast Quarter of said Section 25; and
- 4. A strip of land for a public road of 60 feet uniform width, the North boundary of which strip is described as follows: Commencing at a point on the North line of Lot 5 where said North line is intersected by County State Aid Highway No. 22, thence East approximately 646 feet to the Northeast corner of the Southeast Quarter of the Northwest Quarter of Section 25; and
- 5. That part of Government Lot 5 described as follows: Commencing at the Southeast corner of the Northeast Quarter of the Northwest Quarter of Section 25, thence South 0 degrees 39 minutes East along the North-South quarter line in said Section 25 a distance of 60.00 feet to its intersection with a line drawn parallel with and distant 60 feet South of, as measured at right angles to, the North line of said Government Lot 5, and to the actual point of beginning of the tract of land to be hereby described; thence continuing South 0 degrees 39 minutes East a distance of 290.75 feet, thence due West and parallel with the North line of said Lot 5 a distance of 872.86 feet to its intersection with the centerline of County State Aid Highway No. 22, thence North 36 degrees 21 minutes 20 seconds East along said centerline a distance of 361.0 feet to its intersection with a line drawn parallel with and distant 60 feet South of, as measured at right angles to, the North line of said Government Lot 5, thence due East along said parallel line a distance of 655.55 feet to the point of beginning.
- 6. That part of said Government Lot 6 described as follows: Commencing at the Southwest corner of said Government Lot 4, for the purposes of this description, the north line of said Government Lot 5 is assumed to bear West; thence South 00 degrees 39 minutes 00 seconds East, along the North-South quarter line of said Section 25 a distance of 2268.95 feet to the south line of Main Street (now known as East Front Boulevard), as dedicated in COON LAKE EAST FRONT, according to the recorded plat thereof, Anoka County, Minnesota, and to the point of beginning of the property to be described: thence North 77 degrees 50 minutes 32 seconds West a distance of 5.10 feet; thence South 00 degrees 01 minutes 03 seconds East a distance of 371.36 feet to the south line of said Government Lot 6; thence North 89 degrees 51 minutes 42 seconds East along said south line a distance of 9.08 feet to the intersection with said North-South quarter line; thence North 00 degrees 39 minutes 00 seconds West along said North-South quarter line a distance of 370.29 feet to the point of beginning

Have caused the same to be surveyed and platted as KATIE'S WAY and do hereby donate and dedicate to the public for public use forever the avenues, boulevard, streets, and drainage and utility easements as shown on the plat. Also dedicating to the County of Anoka the right of access onto County State


