
# LEGACY AT PETERSEN FARMS SECOND ADDITION

Outlot B, Outlot C, and Outlot D, LEGACY AT PETERSEN FARMS, Anoka County Minnesota, according to the recorded plat thereof.

That part of the South Half of the Southwest Quarter of Section 7, Township 32, Range 24, Anoka County, Minnesota, described as follows:

Commencing at the Northeast corner of said South Half of the Southwest Quarter; thence on an assumed bearing of South 89 degrees 52 minutes 15 seconds West, along the north line of said South Half of the Southwest Quarter, a distance of 975.88 feet; thence South 04 degrees 29 minutes 59 seconds West a distance of 231.03 feet; thence South 85 degrees 30 minutes 01 seconds East a distance of 240.00 feet; thence South 04 degrees 29 minutes 59 seconds West a distance of 778.17 feet; thence South 89 degrees 46 minutes 20 seconds West a distance of 59.68 feet; thence South 00 degrees 14 minutes 21 seconds East a distance of 285.28 feet to the south line of said South Half of the Southwest Quarter; thence South 89 degrees 46 minutes 20 seconds West a distance of 776.74 feet to the Point of Beginning of the property to be described; thence North 16 degrees 11 minutes 24 seconds East a distance of 423.21 feet; thence North 53 degrees 08 minutes 38 seconds East a distance of 73.10 feet; thence northwesterly 247.17 feet along a non-tangential curve, concave to the northeast, said curve having a radius of 335.00 feet, a central angle of 42 degrees 16 minutes 24 seconds and a chord bearing of North 50 degrees 58 minutes 41 seconds West; thence South 68 degrees 43 minutes 27 seconds West, not tangent to the last described curve a distance of 50.49 feet; thence South 65 degrees 00 minutes 04 seconds West a distance of 50.78 feet; thence southwesterly a distance of 220.62 feet along a tangential curve, concave to the northwest, said curve having a radius of 479.00 feet and a central angle of 26 degrees 23 minutes 23 seconds; thence southwesterly a distance of 181.21 feet along a tangential reverse curve, concave to the south, said curve having a radius of 615.00 feet and a central angle of 16 degrees 52 minutes 57 seconds; thence South 22 degrees 27 minutes 27 seconds East, a distance of 537.64 feet to the South line of said South Half of the Southwest Quarter; thence easterly along said South line to the Point of Beginning.

Except Parcel 8, ANOKA COUNTY HIGHWAY RIGHT OF WAY PLAT NO 4, Anoka County, Minnesota, according to the recorded plat thereof.

Has caused the same to be surveyed and platted as LEGACY AT PETERSEN FARMS SECOND ADDITION and does hereby dedicate to the public for public use the public ways and the drainage and utility easements as created by this plat.
