

KNOW ALL MEN BY THESE PRESENTS: That we Margaret A. Coleman, single, owner and proprietor and Harvey A. Cartwright and Ethel I. Cartwright, his wife, owners and proprietors of the following described property situate in the County of Anoka, State of Minnesota to wit: That part of the following described property lying West of the center line of the East River Road, so called, as the same is now laid out and constructed, Commencing at the Northwest corner of Section 3 of Township Numbered 30 North, Range 24 West; thence East along the North boundary line of said Township to the one eight Section Corner on the North line of the Northwest quarter (N. W. 14) of said Section Three (3); thence South Twenty Three (23) chains; thence West Thirteen and Ninety Hundredths (13.90) chains; thence South Eight and Eighty-One Hundredths (8.81) chains to the South line of the Northwest quarter of the Northwest quarter (N.W.14, N.W.14); therice West Ten and Forty Hundredths (10.40) chains more or less to the Mississippi River; thence Northwesterly along said river to the intersection of the North boundary line of said Township; thence East on the North boundary line of said Township to the point of commencement saving and excepting 20 acres along the North line of said described tract of land, subject to the right-of-way of the East River Road and also excepting the following described tract, beginning at a point on the South line of the Northwest quarter of the Northwest quarter (N.W. 14, N.W. 14) distant (1127.9 feet West of the Southeast corner thereof; therice North at right angles 240.5 feet; thence West parallel with the South line and the South line extended of the Northwest quarter of the Northwest quarter (N.W. 14, N.W. 14) of said Section Three (3) to the Mississippi River; thence Southerly along said river to the production West of the said South line; thence East on the extended South line of the Northwest quarter of the Northwest quarter (N.W.
