
MISSISSIPPI TERRACE

KNOW ALL MEN BY THESE PRESENTS, That we, the Rum River Lumber Company, a corporation as fee owners and proprietors of the following described tract of land in Anoka County, Minnesota, to-wit: all of Outlot Three (3) N.D. Shaw's Addition to Anoka according to map or plat thereof on file and of record in the office of Register of Deeds in and for Anoka County, Minnesota excepting there from the following described the control of the contro

Commencing at the most Southerly point of said Outlot Three (3), thence Northeasterly along the Southeasterlyiline of said Outlot a distance of four hundred eighty—seven (407) feet to the most Easterly point of said Outlot; thence Northwesterly long the Northeasterly line of said Outlot a distance of two hundred forty—two (242) feet to a point; thence Southwesterly in a direct line to a point on the Mississippi of said Outlot a distance of two hundred forty—two (242) feet to a point; thence Southwesterly in a direct line to a point on the Mississippi River, two hundred (200) feet Northwesterly from the point of commencement; thence Southeasterly along said Mississippi River a distance of

two hundred (200) feet to place of commencement.

Commencing at a point on West line of said Outlot Three (3), said point being the Northeast corner of Lot Seven (7), Auditor's Subdivision No. eighty—seven (87), Anoka County, Minnesota; trence East at right angles to said West line a distance of two hundred twenty (220) feet more or less to the Northeasterly line of said Outlot Three (3), thence Northwesterly on said Northeasterly line two hundred sixty (260) feet more or less to Northwest corner of said Outlot; thence South on said West line one hundred twenty (120) feet more or less to place of commencement; have caused the same to be surveyed and platted as "Mississispi Terrace" and do hereby donate and dedicate to the public for public use forever the Lane as shown on the annexed plat; also subject to easement of record for storm water sewer as shown on the annexed plat two hundred (200) feet to place of commencement.
