
MOORE LAKE HILLS 2nd ADDITION

KNOW ALL MEN BY THESE PRESENTS: that Bronson - Erickson Incorporated, a Minnesota Corporation, owners and proprietors of the following described property situate in the State of Minnesota and County of Anoka, towit: All that part of Lot 9, Meloland Gardens, Anoka County, Minnesota, described as beginning at the Southeast corner of said lot; thence West along the South line thereof a distance of 220.8 feet; thence Northerly and parallel with the East line of said lot a distance of 140 feet; thence West and parallel with said South line a distance of 13 feet; thence Northerly and parallel with said East line to its intersection with the Northwesterly line of said lot; thence Northeasterly along said Northwesterly line to the most Northerly corner of said lot, thence South along said East line to the point of beginning, and that port of Lot 8, Meloland Gardens, Anoka County, Minnesota, described as beginning at a point on the West line of said Lot 8, (for the purpose of this description, said West line of Lot 8 is assumed to be a due North and South line) distant 158.57 feet South of the Northwest corner of Lot 8, thence South 49°10'40" East, a distance of 45 feet; thence Southwesterly to a point on the West line of said Lot 8, a distance of 74.83 feet South of the point of beginning; thence North along the West line of said Lot 8, a distance of 74.83 feet to the point of beginning. Excepting that part of Lot 9, Meloland Gardens, Anoka County, Minnesota, described as beginning at the Northeast corner of said Lot 9, thence South along the East line of said Lot 9, a distance of 158.57 feet; thence North 49º10'-40" West, a distance of 103.66 feet, more or less to the Northwesterly line of said Lot 9; thence Northeasterly along the Northwesterly line of said Lot 9, a distance of 120 feet to the point of beginning, and also excepting that part of Lot 9, Meloland Gardens, Anoka County, Minnesota, described as beginning at a point on the East line of said Lot 9, distant 233.4 feet South of the Northeast corner of said Lot 9, thence South along the East line of said Lot 9, a distance of 116.39 feet; thence North 57º19'-24" West, a distance of 10 feet; thence Northeasterly a distance of 98.24 feet, more or less, to the point of beginning; have caused the same to be surveyed and platted as MOORE LAKE HILLS 2nd ADDITION, and do hereby donate and dedicate to the public for public use forever the Lane as shown on the annexed plat; subject to the Utility and Orainage Easements as shown on the annexed plat.
