

Commencing at the Northwest corner of Morningside Memorial Gardens, Garden of Faith; thence North 1 degree, 02 minutes West, perpendicular to the North line of said Garden of Faith, 27.5 feet; thence South 88 degrees, 58 minutes West, 191.58 feet to the actual point of beginning of the tract of land to be described; thence South 14 degrees, 15 minutes West, 99.46 feet; thence on a tangential curve to the left, (having a central angle of 68 degrees, 07 minutes) a distance of 188.6 feet; thence on a tangential curve to the left, compound to the last described curve (having a central angle of 36 degrees, 40 minutes) a distance of 41.88 feet; thence North 89 degrees, 28 minutes East tangent to the last described curve, 10.0 feet; thence South 0 degrees, 32 minutes East, 61.26 feet; thence North 88 degrees, 58 minutes East, 11.11 feet to a corner in the boundary of Morningside Memorial Gardens; thence South 88 degrees, 58 minutes West, 353.18 feet to the Southwest corner of Morningside Memorial Gardens; thence North 458.88 feet; thence North 88 degrees, 58 minutes East, 256.56 feet to the point of beginning.
