


NORTHDALE SECOND ADDITION

KNOW ALL MEN BY THESE PRESENTS: that Alberta Mary Minder and E.G. Minder, Jr., her husband, owners and proprietors of the following described property situate in the State of Minnesota and County of Anoka, to-wit: - That part of the East 1/2 of the SW 1/4 of Section 12 and of the East 1/2 of the NW 1/4 of Section 13, Township 31, Range 24, described as follows: Beginning at the SE 1/4 corner of Lot 25, Block 1, of Northdale First Addition according to the map or plat thereof on file and of record in the office of the Register of Deeds in and for Anoka County, Minnesota, thence S. 67° 18' 18" E., along the NE 1/4 side of 115th Avenue NW (formerly 115th Street NE) as laid out in said Addition, 465 feet to the most Easterly corner of said Addition, thence S. 22° 41' 42" W., 50 feet to the NE 1/4 corner of Lot 1, Block 6 of said Addition, thence S. 67° 18' 18" E., 40 feet, thence N. 22° 41' 42" E., 50 feet; thence NE 1/4, Northerly and NW 1/4 along a tangential curve to the left with a radius of 2415.21 feet, a distance of 2571.36 feet, thence N. 38° 18' 18" W., 62.5 feet along a line tangent to the last described curve; thence NW 1/4 along a tangential curve to the right with a radius of 644.93 feet, a distance of 405.22 feet; thence N. 2° 18' 18" W., 130.81 feet along a line tangent to the last described curve, thence N. 82° 58' 18" W., 49.15 feet, thence Westerly on a tangential curve to the left with a radius of 403.99 feet, a distance of 147.42 feet, thence Westerly on a tangential curve to the right with a radius of 140.32 feet a distance of 56.55 feet, thence N. 80° 47' 18" W., 121.32 feet along a line tangent to the last described curve, thence S. 2° 18' 18" E., 159.94 feet; thence SE 1/4 on a tangential curve to the left with a radius of 1014.93 feet, a distance of 637.7 feet, thence S. 38° 18' 18" E., 326 feet along a line tangent to the last described curve, thence S. 47° 49' 49" W., 137.0 feet; thence S. 51° 41' 42" W., 133.31 feet; thence S. 38° 18' 18" E., 50 feet to the most Westerly corner of Lot 1, Block 1, of said Addition; thence NE 1/4 along the NW 1/4 line of said Lot 1, 135 feet to the most Northerly corner of said Lot 1; thence SE 1/4, Southerly and Southwesterly along the Easterly side of Block 1 of said Addition to the point of beginning. Have caused the same to be surveyed and platted as NORTHDALE SECOND ADDITION, and do hereby donate and dedicate to the public for public use forever the streets, avenues, and drive as shown on the annexed plat. Also subject to Drainage and Utility Easements as shown on the annexed plat for use of municipality or other public utilities, for installation and maintenance of facilities installed in and over said easements to serve adjacent or other premises in the vicinity.
