The Southwest Quarter of the Northeast Quarter of Section 23, Township 31, Range 23, Anoka County, Minnesota except that part of the east 345 feet of the Southwest Quarter of the Northeast Quarter of Section 23, lying southerly of a 100.00 foot strip of land which lies 50 feet on each side of the following described centerline:


