
PHILLIPS 1ST ADDITION

All that part of the Northwest 1/4 of the Northeast 1/4 of Section 15, Township 31, Range 24, Anoka County, Minnesota, described as follows: Commencing At the Southwest corner of said Northwest 1/4 of the Northeast 1/4; thence East along the South line thereof a distance of 272.0 feet to the actual point of beginning of the tract of land to be described; thence North at right angles a disance of 264.0 feet; thence West at right angles a distance of 87.97 feet, more or less, to the Easterly right of way line of Hanson Boulevard as described in Warranty Deed filed September 2, 1964 and recorded in Book 650 of Deeds, Page 537, in the Office of the Register of Deeds in and for said Anoka County; thence Northeasterly along the Easterly right of way line of said Hanson Boulevard a distance of 383,46 feet, more or less, to the Southerly right of way line of U.S. Highway No. 10 as described in said Warranty Deed recorded in Book 650 of Deeds, Page 537; thence Southeasterly along said Southerly right of way line a distance of 200.0 feet; thence Southwesterly a distance of 574.51 feet, more or less, to a point on the South line of said Northwest 1/4 of the Northeast 1/4 distant 200.0 feet East of the actual point of beginning; thence West along said South line of said Northwest 1/4 of the Northeast 1/4 a distance of 200.0 feet to the actual point of beginning.
