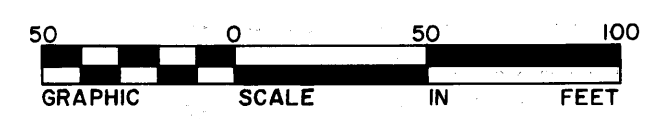
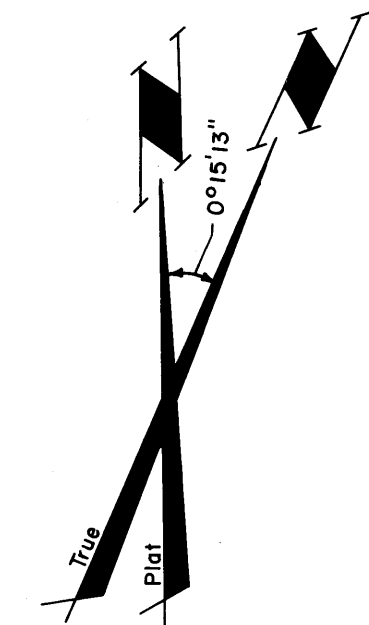
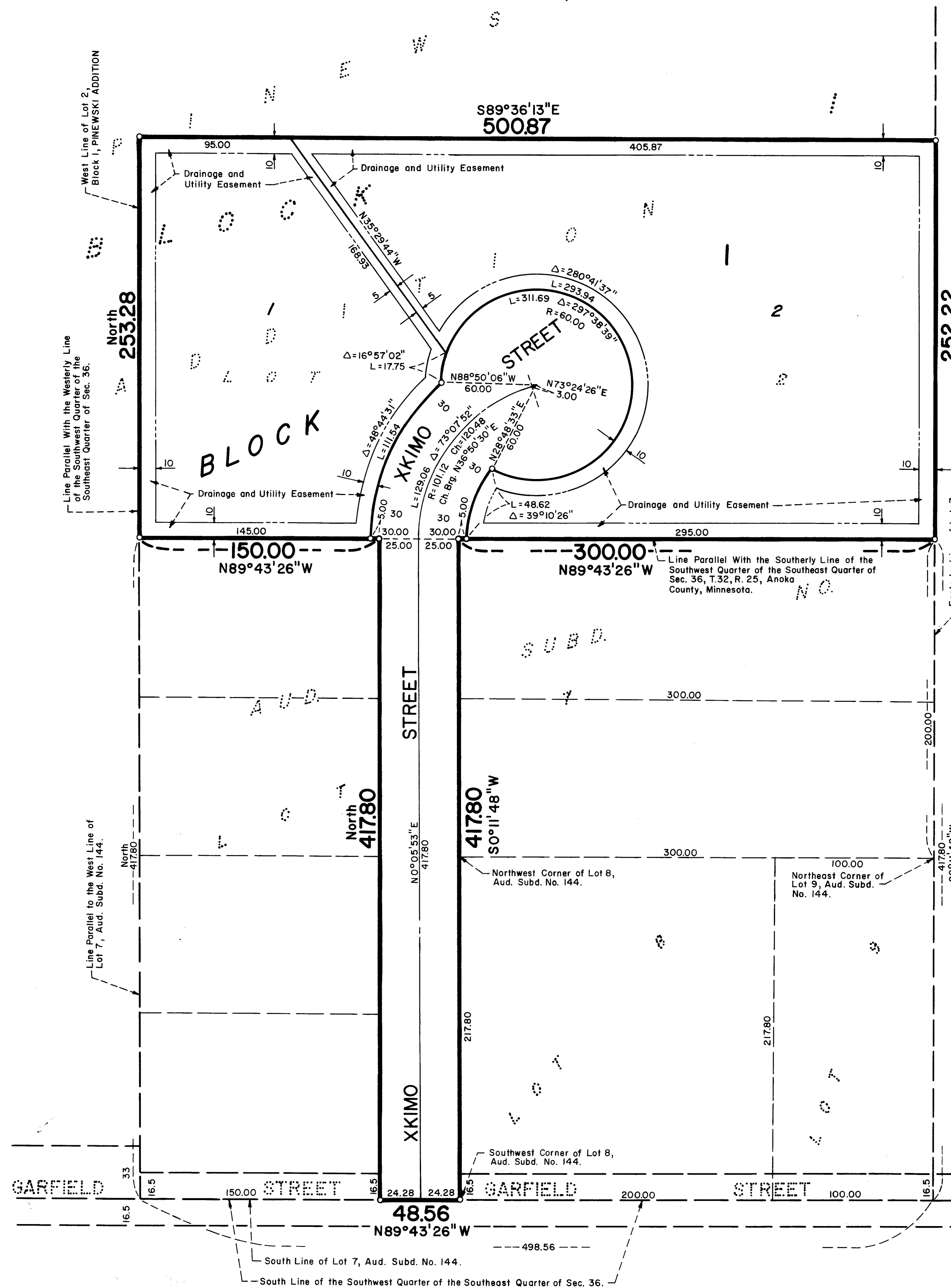


PINEWSKI SECOND ADDITION

Lot 2, Block 1, PINEWSKI ADDITION, Anoka County, Minnesota.

And, that part of Lot 7, Auditor's Subdivision No. 144, Anoka County, Minnesota, described as follows: Commencing at a point on the easterly line of said Lot 7 distant 200.00 feet northerly of the northeast corner of Lot 9 in said subdivision; thence westerly on an assumed bearing of North 89 degrees 43 minutes 26 seconds West, parallel with the southerly line of said Lot 7, a distance of 300.00 feet to the point of beginning of the land to be described; thence continuing North 89 degrees 43 minutes 26 seconds West a distance of 50.00 feet; thence on a bearing of South, parallel with the westerly line of said Lot 7, a distance of 417.80 feet to said southerly line of said Lot 7; thence South 89 degrees 43 minutes 26 seconds East, along said southerly line, a distance of 48.56 feet to the southwest corner of Lot 8, Auditor's subdivision No. 144; thence North 0 degrees 11 minutes 48 seconds East, along the westerly line of said Lot 8 and its northerly extension, a distance of 417.80 feet to the point of beginning.
