

RIVER BANK ADDITION TO ANOKA, ANOKA COUNTY, MINNESOTA

KNOW ALL MEN BY THESE PRESENTS: That I, George W. Green, owner and proprietor of the following described property to wit; all that part of Government Lot four (4) Section six (6) Township thirty one north (T31N) Range twenty four west (R24W) of the fourth Principal Meridian at 4th PM, Anoka County, Minnesota, beginning at a point designated by a stake on the west or right bank of the Rum river on the line between Ranges twenty four (24) and twenty five (25) eighteen chains (18) north from the one quarter Section corner between sections one (1) and six (6) said Towns and ranges; Thence south twenty nine degrees and thirty minutes east (S 29° 30'E) thirteen chains (13) and fourteen links (14) to an oak tree; Thence south eleven degrees and fifteen minutes east (S 11° 15'E) three chains (3) and seventy four links (74) to a stake; Thence south eleven degrees and forty five minutes west (S 11° 45'W) seven chains (7) to a stake; Thence south forty seven degrees west (S 47° W) four chains (4) and sixty one links (61) to a stake; Thence at right angles to the last course, southeasterly to the river; Thence following up the center line said Rum river to a point due east of the point of beginning; Thence west to the point of beginning, excepting land, conveyed to Ruel L. Hall recorded in Book S of deeds pages 340 and 341 as follows, beginning at the southwest corner of the land heretofore described; Thence in a northeasterly direction along the westerly line said land, two hundred thirty nine feet (239); Thence at right angles, easterly, fifty feet (50); Thence at right angles in a southerly direction ninety feet (90); Thence at right angles in a easterly direction five feet (5); Thence at right angles in a southerly direction one hundred forty nine feet (149) to the southerly line said land; Thence at right angles in a westerly direction fifty five feet (55) to the point of commencement; and also excepting the following, beginning at the southeast corner of lot five (5) Block two (2) Riverside Addition, thence, east, along the extended north line of Pleasant Street, to the Rum river; Thence south along the west bank said Rum river to the extended south line Pleasant Street; Thence west along the extended south line Pleasant Street to River Street so called; Thence north along the east line said River Street to the point of beginning. The easterly one half (E 1/2) of Bank Avenue, formerly known as River Street on Plat of Riverside Addition, now vacated. The land herein described being all of the lands, together with other lands lying between the Rum river and the east line of Blocks one (1), two (2), five (5) and six (6) of Riverside Addition, excepting the west one half (W 1/2) of Bank Avenue, formerly designated as River Street on the Plat of Riverside Addition, now vacated, have caused the same to be Surveyed and Platted as RIVER BANK ADDITION to Anoka, Anoka County, Minnesota and do hereby donate and dedicate to the Public use forever all Streets, Avenues and Alleys as shown on the annexed Plat.
