I hereby certify that in accordance with the provisions of Chapter 508, Minnesota Statutes of 1949, as amended, I have surveyed the following described tract of land in the County of Anoka, and State of Minnesota, to-wit: That part of Government Lot 2 and 3 Section 15, Township 30, Range 24 lying Westerly of the Westerly right of way line of County State Aid Highway #1 (also known as East River Road); said Westerly right of way line is a line which is 50 feet Southwesterly and parallel with following described line: Beginning at a point on the East-West quarter line of said Section 15, Township 30 North, Range 24 West, distance 1612.34 feet West of the East Quarter corner of said Section; thence Northwesterly at an angle of 113° 18' (when measured from East to North) with said East-West quarter line for 900 feet and there terminating; lying Northerly of the Northerly line of Johnson's River Lane Addition and its Northeasterly and Southwesterly extensions of said Northerly line; and lying Southerly of the Southeasterly line of Lot 7 Revised Auditor's Subdivision No. 23, Anoka County, Minnesota, also being the northerly line of the 30 feet street lying northerly of Blocks 21 and 22, Fridley Park (The above described parcel also being all of Block 23 and said Blocks 21 and 22, Fridley Park and all vacated alleys and streets lying adjacent to said Blocks).
