

KNOW ALL MEN BY THESE PRESENTS: that George L. Walquist and Mildred E. Walquist, his wife, owners and proprietors and that Everett H. Thompson and Marian A. Thompson, his wife, and Edward A. Miller and Toni Ann Miller, his wife, purchasers under contract for deed of the following described property situate in the State of Minnesota and County of Anoka, to wit: that part of the NW 1/4 of the SE 1/4 of Section 24, Township 31, Range 24, described as follows: - Beginning at the intersection of the easterly right of way line of Foley Boulevard (said line being 33 feet easterly of the centerline of said Foley Boulevard) and a line 533 feet south and parallel with the north line of said NW 1/4, said 533 feet is measured along a line parallel with the east line of said NW 1/4 of the SE 1/4; thence North 88° 19' 45" East (said bearing is assumed) along a line parallel with said north line of the NW 1/4 to a point 333 feet west of the said east line of the NW 1/4 as measured along a line parallel with said north line, thence North 2° 43' 32" West a distance of 34.94 feet; thence North 88° 19' 45" East a distance of 334.66 feet more or less to the said east line of the NW 1/4; thence North 0° 00' along said east line a distance of 330.03 feet; thence South 88° 19' 45" West a distance of 741.01 feet; thence South 72° 49' 12" West a distance of 69.88 feet more or less to the said easterly right of way line; thence southeasterly along said right of way line to the point of beginning; have caused the same to be surveyed and platted as RUSTIC OAKS; and do hereby donate and dedicate to the public for public use forever the Lane and Street as shown on the annexed plat, subject to the Utility and Drainage Easements as shown on the annexed plat for use of municipality or other public utilities, also subject to the County Highway Easement as shown on the annexed plat.
