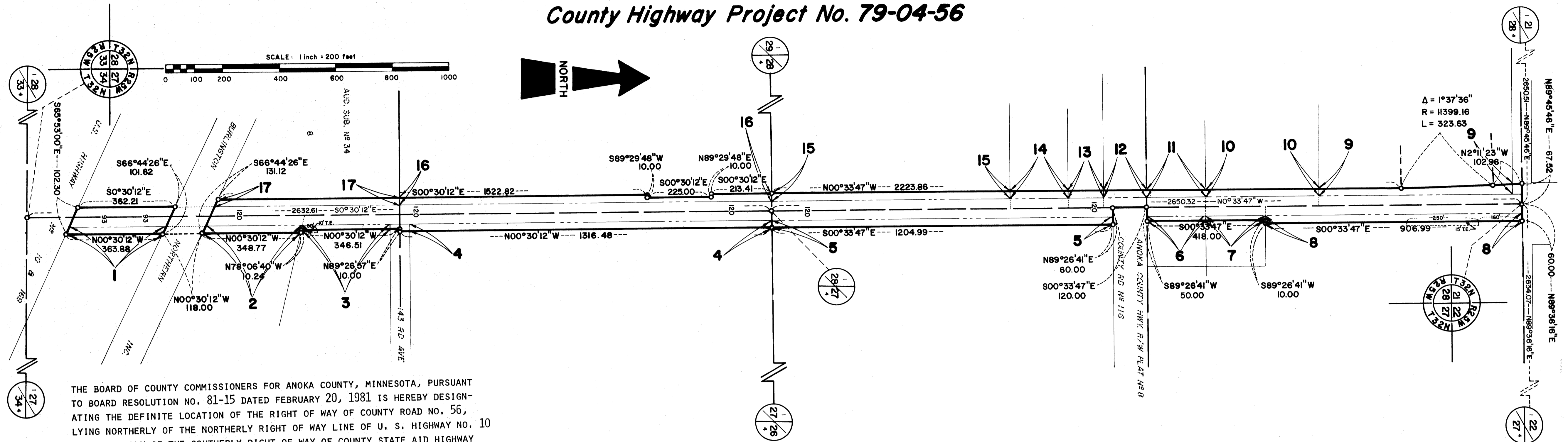


ANOKA COUNTY HIGHWAY RIGHT-OF-WAY PLAT NO. 16

THE BOARD OF COUNTY COMMISSIONERS FOR ANOKA COUNTY, MINNESOTA, PURSUANT TO BOARD RESOLUTION NO. 81-15 DATED FEBRUARY 20, 1981 IS HEREBY DESIGNATING THE DEFINITE LOCATION OF THE RIGHT OF WAY OF COUNTY ROAD NO. 56, LYING NORTHERLY OF THE NORTHERLY RIGHT OF WAY LINE OF U. S. HIGHWAY NO. 10 AND SOUTHERLY OF THE SOUTHERLY RIGHT OF WAY OF COUNTY STATE AID HIGHWAY NO. 5 IN THE CITY OF RAMSEY.

THAT PORTION OF SAID HIGHWAY LOCATED IN SECTIONS 15, 21, 22, 27 AND 28, TOWNSHIP 32, RANGE 25, ANOKA COUNTY, MINNESOTA AS SHOWN ON THIS PLAT EFFECTED BY THE COUNTY OF ANOKA, DEPARTMENT OF HIGHWAYS, IS HEREBY CERTIFIED TO BE THE OFFICIAL PLAT OF THAT PORTION OF SAID COUNTY HIGHWAY WITHIN SAID SECTIONS PURSUANT TO MINNESOTA STATUTES 160.085.
