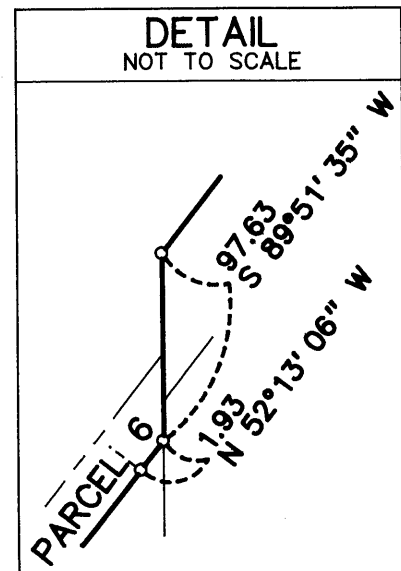
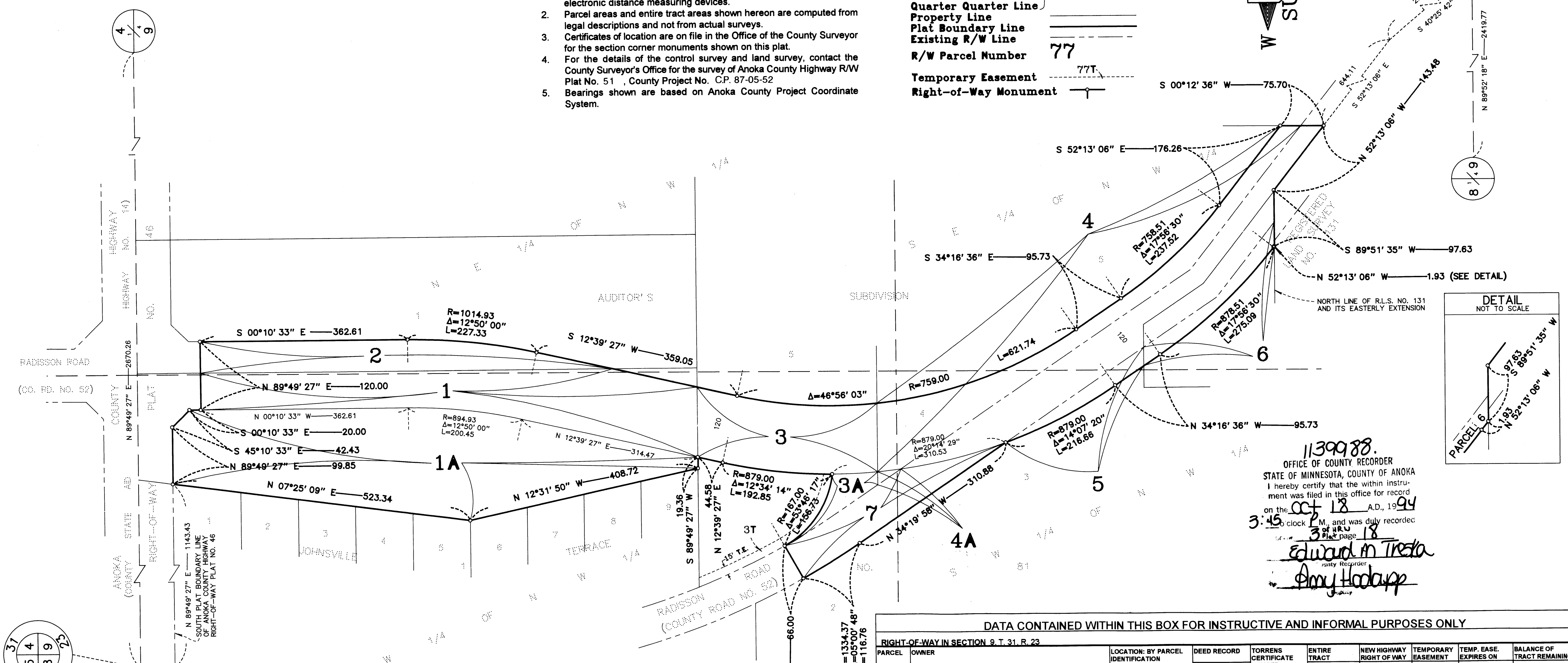
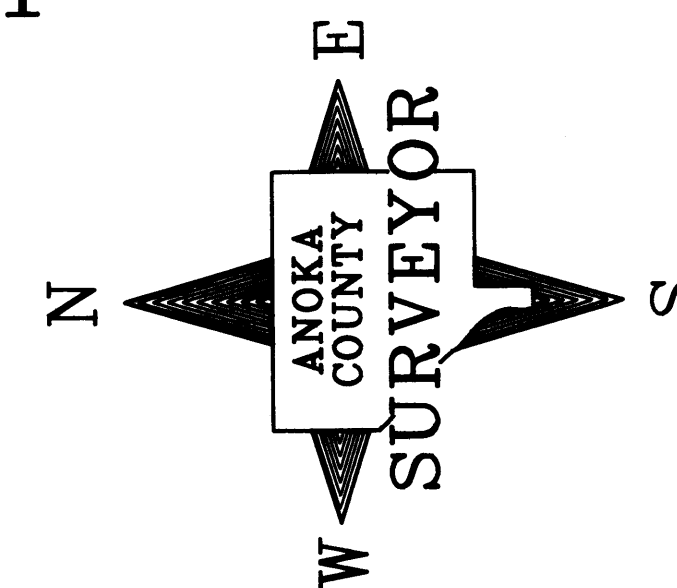


PROCEDURAL STATEMENTS
