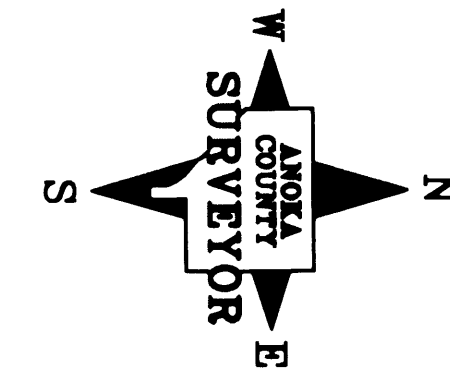


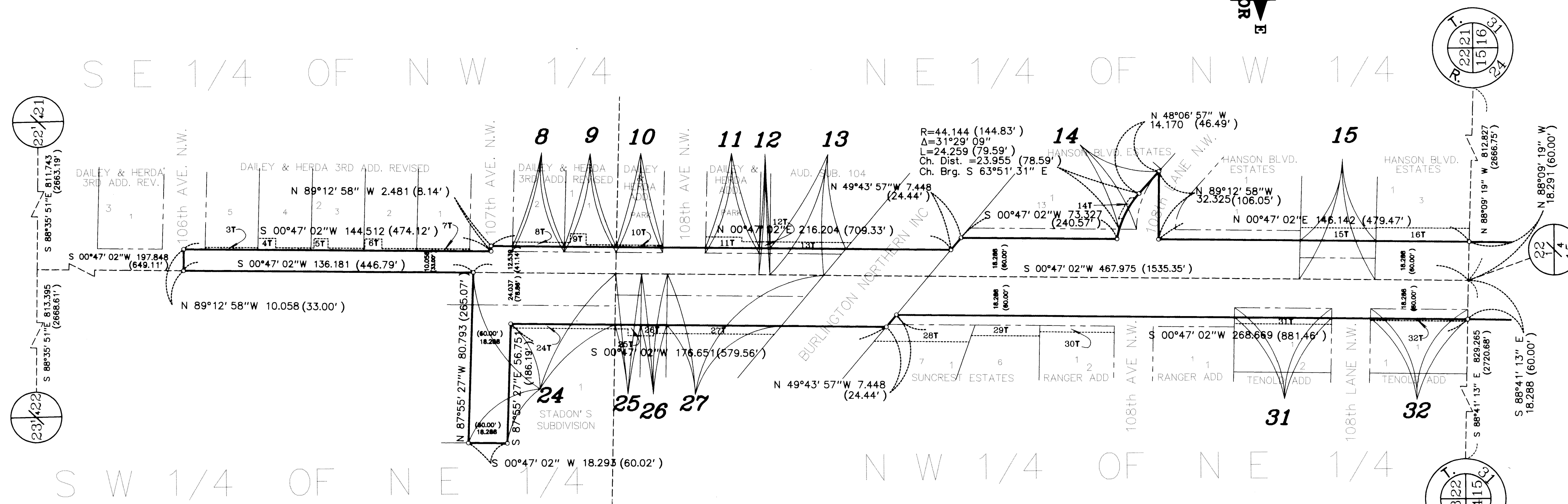
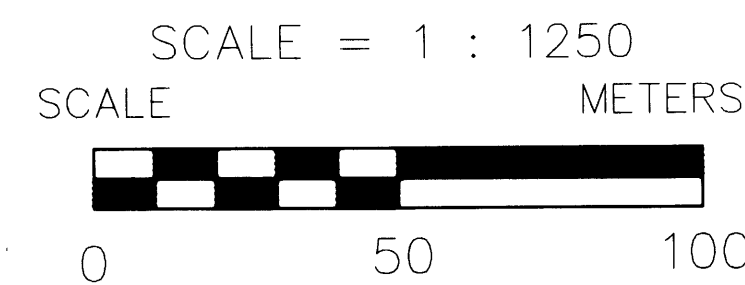

- Bearings shown are based on Anoka County Project Coordinate System.
- Distances shown are in meters unless denoted as feet (xxx.xx').
