

The above-entitled matter came on for hearing on the Sth day of <u>April</u>, 1988, at the appellate courtroom at the Anoka County Courthouse in the City of Anoka in said county and state, before the Examiner of Titles to whom said matter has been duly referred pursuant to Minnesota Statutes, Section 508.13, to hear the evidence in said cause and report his conclusions therefrom, and who has filed his report herein; and the court having duly considered the Petition, Report of the Examiner and the evidence addressed by the Petition, finds:

1. That on the 20th day of January, 1987, the Registrar of Titles entered Certificate of Title No. 59390 in Vol. 188 of the Register of Titles at page 30 to Thomas S. Anderson and Kathleen A. Anderson, husband and wife, as joint tenants, for land in Anoka County described as follows:

Lot 4, Block 3, SUMMER CHACE THIRD ADDITION, according to the plat on file in the office of the Registrar of Titles, Anoka County, Minnesota. 2. That said Certificate of Title No. 59390 contains, among others, the memorial of Document No. 158813, a mortgage in favor of ICA Mortgage Corporation; Document No. 158814, an Assignment of Mortgage Document No. 158813 to Imperial Savings Association; and Document No. 169794, an Assignment of Mortgage Document No. 158813 to Security Pacific National Bank as Trustee under the Pooling and Servicing Agreement, dated as of February 1, 1987, Series 1987-FB2.
