

KNOW ALL MEN BY THESE PRESENTS that Schilling Construction Inc., a Minnesota Corporation, owner of the following described property situated in the County of Anoka and State of Minnesota towit:

That part of the North One Half of the North One Half of the Northwest Quarter (N ½, N ½, NW ¼) of Section 9, Township 31, Range 22, Anoka County, Minn., lying easterly of the easterly right of way line of Old U.S. Highway No. 8 (Lake Drive) and southerly and easterly of the following described line:

Commencing at the Northwest corner of said NW 4, thence easterly along the North line of said NW 4 a distance of 2,308.50 feet to the actual point of beginning of line to be described; thence southerly at right angles to said North line of NW ¼ a distance of 231.00 feet; thence westerly on a line parallel with the said North line of the NW 4, a distance of 1751.00 feet; thence southerly at a right angle a distance of 180.00 feet; thence westerly at a right angle a distance of 2.00 feet; thence on a tangential curve to the left, its central angle being 22 degrees, 57 minutes, 00 seconds, and its radius being 246.31 feet, a distance of 98.66 feet; thence tangent to said curve, 1.03 feet; thence following a tangential curve to the right, its central angle being 23 degrees, 00 minutes, 00 seconds, and its radius being 221.18 feet, a distance of 88.79 feet; thence tangent to said curve, 188.43 feet, more or less, to the easterly right of way line of Old Highway No. 8 and there terminating.

EXCEPTING THEREFROM THE FOLLOWING DESCRIBED TRACT:

Beginning at the intersection of the south line of said N 1/2, N 1/2, NW 1/4 with the easterly right of way line of Old Highway No. 8; thence easterly along said south line a distance of 300.00 feet; thence northerly at a right angle to said south line, a distance of 146.02 feet; thence westerly on a line parallel with said south line of N ½, N ½, NW ¼, to said easterly line of Old Highway No. 8; thence southwesterly to the point of beginning.

AND ALSO EXCEPTING:

That part lying easterly of the following described line:

Beginning at a point on the north line of said N ½, N ½, NW ¼, said point being 2374.50 feet easterly of the Northwest corner thereof; thence southerly at a right angle to said north line, to the south line of said N ½, N ½, NW ¼ and there terminating.
