


# SYLVAN HILLS PLAT 5

KNOW ALL MEN BY THESE PRESENTS: that Carlson-LaVine, Inc., a Minnesota Corporation, owns and proprietors of the following described property situate in the State of Minnesota and County of Anoka, to-wit: All that part of the West 1/2 of the SW 1/4 of Section 14, Township 30, Range 24, Anoka County, Minnesota, or all that part of Lots 22 thru 31, Block 12, Lowell Addition to Fridley Park lying westerly of State Highway N-56, all of Lots 12 thru 21 of said Block 12, and parts of Lots 10, 11 and 32 in said Block, all of Block 11 in said Addition and the vacated alleys in said Block 11, Lots 1 thru 6, 22 thru 32 and part of Lot 7 and 11 thru 21, Block 10 in said Addition, and that part of the vacated alleys in said Blocks 10 and 12, and all of vacated 3rd Street and 2 1/2 Street and part of 64th Avenue N.E. described as follows: Beginning at a point on the North line of said SW 1/4 distant 438.78 feet east of the Northwest corner of said SW 1/4; thence southerly along a line parallel with the westerly right of way line of State Highway N-56 (also known as University Avenue) a distance of 606.21 feet; thence westerly a distance of 165.12 feet more or less to the curve point on the North boundary line of Sylvan Hills Plat 3, said curve point being 60 feet North of Lot 7, Block 1 of said Plat 3; thence Southeasterly along the Northerly boundary line of said Plat 3 and the boundary line of Sylvan Hills Plat 4 to the Southwest corner of Lot 6, Block 1 of said Plat 4; thence Northeasterly, Northwesterly and Easterly along the boundary lines of said Plat 4 to the Northeast corner of said Plat 4, said corner being on the said Westerly right of way line; thence Northerly along said Westerly right of way line to a point which is 158 feet South of the North line of said SW 1/4; thence West and parallel with said North line to the point of intersection with a line parallel with said Westerly right of way, and distant 1043.58 feet East of the Northwest corner of said SW 1/4, as measured along said North line of the SW 1/4; thence North along the last described line to the North line of said SW 1/4; thence West along the North line a distance of 584.8 feet to the point of beginning. Excluding from the above described portion whose owners and proprietors are Gift House Stamps, Inc., a Minnesota Corporation, of the following described property situate in the State of Minnesota and County of Anoka, to-wit: Commencing on the North line of the West 1/2 of the SW 1/4 of Section 14, Township 30, Range 24, Anoka County, Minnesota, distant 208.48 feet East of the Northwest corner of said SW 1/4; thence South and parallel with said Westerly right of way line a distance of 158 feet to the actual point of beginning; thence continuing South and parallel with said right of way line a distance of 450 feet; thence East and parallel with said North line of SW 1/4 to said Westerly right of way line; thence North along said Westerly right of way line a distance of 450 feet to a point 158 feet South of the North line of said SW 1/4; thence West and parallel with said North line to the actual point of beginning; have caused the same to be surveyed and platted as SYLVAN HILLS PLAT 5, and do hereby donate and dedicate to the public for public use forever the Drive, Avenue, Lane and Streets as shown on the annexed plat, subject to the Utility and Drainage Easements as shown on the annexed plat for use of municipality or other public utilities.
