

Tract No. 1 Beginning at the intersection of the center line of County State Aid Highway No. 18 as now laid out and travelled and the South line of said NE of the SW4; thence Northeasterly along the center line of said County State Aid Highway No. 18 a distance of 165 feet; thence East on a line parallel to the South line of said NE of the SW a distance of 264 feet; thence Southwesterly and parallel to the center line of said County State Aid Highway No. 18 a distance of 165 feet to the South line of said NE of the SW; thence West along said South line a distance of 264 feet to the point of beginning.

Tract No. 2 Beginning at the Northeast corner of the NE of the SW; thence Due West along the North line of said NE of the SW a distance of 58.6 feet to the center line of County State Aid Highway No. 18; thence South 32°55' West along said center line a distance of 550.17 feet; thence South 44°11' West along said center line a distance of 342.85 feet; thence Southeasterly to the Southeast corner of said NE# of the SW#; thence North along the East line of said NE# of the SW# to the point of beginning.


