
## TITTERUD ADDITION

That part of the Southeast quarter of the Southwest quarter of Section 22, Township 32, Range 23, Anoka County, Minnesota, described as commencing at the Southeast corner thereof; thence on an assumed bearing of North 88 degrees 19 minutes 40 seconds West along the South line of said Southeast quarter of Southwest quarter 296.72 feet to the point of beginning of the land to be described; thence North 48 degrees 54 minutes 11 seconds West 615.29 feet; thence Northwesterly 390.61 feet along a tangential curve concave to the Northeast having a radius of 737.49 feet and a central angle of 30 degrees 20 minutes 47 seconds; thence North 18 degrees 33 minutes 24 seconds West and tangent to said curve 299.74 feet; thence Northwesterly along a tangential curve concave to the Southwest having a radius of 818.51 feet and an arc distance of 415.00 feet to a point on the North line of said Southeast quarter of Southwest quarter, distant 29.6 feet East from the Northwest corner thereof; thence Westerly along said North line 29.6 feet to the Northwest corner thereof; thence Southerly along the West line thereof to the Southwest corner of said Southeast quarter of Southwest quarter of Section 22; thence Easterly 1033.78 feet along the South line of said Southeast quarter of Southwest quarter of Section 22 to the point of beginning.
