

Osborne, his wife, owners and proprietors of the following described property situate in the County of Anoka, State of Minnesota to-wit: That part of the Southeast 14 of the Northeast 14 of Section 1, Township 30, Range 24 described as follows: Commencing at a point on the West line of said Southeast 14 of the Northeast 14 150.33 feet South from the Northwest corner thereof, thence East at right angles with the West line of said Southeast 1/4 of the Northeast 1/4 315.84 feet more or less to the Southwesterly line of U.S. Highway Number 10 (so-called), as the same is now laid out and constructed, thence Southeasterly along the Southwesterly line of said U.S. Highway Number 10 to the East line of said Southeast 1/4 of the Northeast 1/4, thence South along said East line to the Southeast corner of the Southeast 1/4 of the Northeast 1/4 thence the Northeast 1/4, thence West along the South line thereof 399 feet, thence North parallel with the East line thereof 156.18 feet, thence Northwest parallel with the Southwesterly line of said U.S. Highway Number 10, 1022.58 feet more or less to a point on a line drawn East at right angles with the West line of said Southeast 1/4, of the Northeast 1/4 from a point thereon 366 feet South of the point of beginning, thence West along said line 137 feet more or less to the West line of said Southeast 1/4 of the Northeast 1/4, thence North along said West line 366 feet to the point of beginning, have caused the same to be surveyed and platted as WARREN ADDITION and do hereby donate and dedicate to the public for public use forever the Streets, Avenue, Drive and Road as shown on the annexed plat, in wit-ness whereof we have hereunto set our hands and seals this 30th As to Walter F.
