Clendenen, husband and wife, fee owners of the property described below as Tract "B", both tracts of which are situated in Columbus Township, Anoka County, Minnesota, have caused the real property described below as "PLAT DESCRIPTION" to be surveyed and platted as WILDWOOD ESTATES PLAT 2, and do hereby donate and dedicate to the public for public use forever, 140th Avenue and Julliard Street as shown on the plat, and drainage and utility easements as shown on the plat:

Description of Tract "A":

That part of the East Half of the Southwest Quarter of Section 26 and that part of the North Half of the Northwest Quarter of Section 35, all in Township 32 North, Range 22 West, Anoka County, Minnesota, described as follows:

Commencing at the northwest corner of said Section 35; thence North 89 degrees 32 minutes 50 seconds East, assumed bearing, along the north line of said Section 35, a distance of 1802.5 feet to the point of beginning; thence South O degrees 27 minutes 09 seconds West, 738.09 feet to the south line of the North 738 feet of said North Half of the Northwest Quarter; thence South 89 degrees 32 minutes 50 seconds West, along said south line, a distance of 182.38 feet; thence South 1 degree 38 minutes 09 seconds West, 194.09 feet to the southeasterly extension of the north line of the Lester J. Trombley tract as described on a Quit Claim Deed, recorded in Book 834 of Deeds, page 186; thence North 87 degrees 21 minutes 15 seconds West, along said southeasterly extension and along the north line of said Lester J. Trombley tract, 540.00 feet to the southerly extension of the west line of the Duane A. Commencing at the southwest corner of the North Half of the Northwest Quarter of Section 35; thence easterly, along the south line of the North Half of the Northwest Quarter, a distance of 607.9 feet to the southwest corner of the Lester J. Trombley tract as described on a Quit Claim Deed, recorded in Book 832 of Deeds, page 393; thence northerly, parallel with the west line of North Half of the Northwest Quarter of Section 35, and along the west line of said Lester J. Trombley tract, a distance of 450 feet to the northwest corner of said Lester J. Trombley tract; thence easterly, parallel with the south line of the North Half of the Northwest Quarter and along the north line of said Lester J. Trombley tract, a distance of 193 feet to the northeast corner of said Lester J. Trombley tract; thence southerly, parallel with the west line of the North Half of the Northwest Quarter, a distance of 21 feet to the northwest corner of the Lester J. Trombley tract as described on a Quit Claim Deed, recorded in Book 834 of Deeds, page 186; thence southeasterly, along the north line of said Lester J. Trombley tract, a distance of 260.65 feet to the southerly extension of the west line of the Duane A. Brown tract as described on Quit Claim Deed, recorded in Book 1032 of Deeds, page 470; thence northerly, parallel with the west line of the North Half of the Northwest Quarter of Section 35 and along the west line of said Duane A. 
